Item 4**Other Business Activities**

Jason M. Williams, Andrew J. Robbins, and Jordan C. Hansen are all owners and members of Strata Holdings, LLC. Strata Holdings, LLC is a holding company whose ownership is as follows: Andy Robbins and Jason Williams each have a 32.5% ownership, Jordan Hansen has a 15% ownership and Cache Asset Management has a 20% ownership.

Strata Holdings, LLC is an investment holding company.

William R. Moreton is the President/Managing Member of Moreton Capital Markets, LLC, a related broker dealer under common ownership and control, as well as the President of Moreton & Co. an insurance broker, Town & Country Holding Co., a life insurance holding company and Hampton Soules, an insurance company. These activities combined are estimated to utilize approximately ninety (90%) percent of Mr. Moreton's time.

William R. Moreton is a broker/dealer agent with Moreton Capital Markets, LLC. Jason Williams, Andrew Robbins, and Jordan Hansen are registered representatives of Moreton Capital Markets, LLC, each working in administrative capacities. Each of the four aforementioned individuals utilize less than 3 hours per week in their capacities with Moreton Capital Markets, LLC.

Moreton Capital Markets, LLC, (MCM) is an affiliated broker/dealer and member of the Financial Industry Regulatory Authority (FINRA) and SIPC, as well as various state jurisdictions. MCM is a limited purpose broker/dealer that shares commissions with other broker/dealers on accounts referred to them by MCM or its affiliates.*

MCM has commission sharing agreements with broker/dealers that can also be a RIA that MAM has referral agreements with. In the event securities accounts are opened or securities transactions are placed by a client's Investment Advisor Representative and MCM has a commission sharing agreement with that broker/dealer, MCM would receive a portion of the commission received by the broker/dealer, this commission sharing arrangement would not increase the amount of commission normally charged by the broker/dealer. This commission sharing arrangement would present a conflict of interest.

MAM does not refer clients to MCM, but MCM and MAM could have the same client referrals depending upon the type of services the client requires. MAM could receive advisory referral fees for advisory services and MCM could share in security commissions for securities, mutual funds and variable contracts. This would also present a conflict of interest.

William R. Moreton is the president of Moreton & Company, an insurance broker, through which commercial insurance products and employee benefit plans are offered. This activity utilizes the bulk of Mr. Moreton's time, over 30 hours per week.

Town & Country Life Insurance Co. is a related insurance carrier whose primary products are deferred annuities and group dental insurance, in business since 1955. William R. Moreton is the chairman and President of Town & Country Life. Town & Country is owned 100% by Town & Country Holding Co. This activity utilizes approximately (2%) of Mr. Moreton's time.

Jason M. Williams is an adjunct professor at Webster University, teaching a course in economics to MBA students. This activity utilizes approximately 6 hours per week of Mr. Williams' time.

Arvel K. Richards is a Regional Director for Integrated Builders Group. This activity utilizes less than 20 hours per week.

Item 5**Additional Compensation**

Aside from the advisory fees received from MAM, Williams, Robbins and Hansen each receive a salary and share in earnings from Moreton Asset Management, LLC operations according to their percentage ownership. Ownership percentages are roughly as follows: Robbins and Williams at 32.5% each, and Hansen at 15%.

As a 5% equity owner of MAM, Mr. Moreton is entitled to a 5% share of earnings from MAM operations.

There is no compensation paid by Strata Holdings, Inc.

Jason M. Williams receives compensation from Webster University in his capacity as an adjunct professor.

Arvel K. Richards receives compensation from Integrated Builders Group in his capacity as a regional director and from Moreton Asset Management in his capacity as a Regional Director.

Item 6**Supervision**

Andrew Robbins is the acting Chief Compliance officer for the Investment Advisory Activities (IA) of MAM. Robbins will be responsible for supervising the activities of Jason Williams, Jordan Hansen, and Arvel Richards. Because Andrew Robbins is himself an IAR and will also be active in the IA activities of the firm, Jason Williams will supervise the activities of Andrew Robbins.

All financial recommendations will be reviewed by at least two of: Andrew Robbins, Jason Williams, and Jordan Hansen.

Portfolio recommendations and transactions, along with account reviews will be the responsibility of Jordan Hansen, Andrew Robbins and Jason Williams.

Account review for investment activity, updated objectives, and any changes in risk tolerance or liquidity needs will be done at least annually, unless it is determined that reviews are required on a more frequent basis.
