Investment Advisor representative(s) of AWC are registered representative(s) of Raymond James Financial Services, Inc. (RJFS), member FINRA/SIPC, which is a wholly owned subsidiary of Raymond James Financial, Inc. RJFS clears its securities transactions on a fully disclosed basis through Raymond James & Associates, Inc. (member NYSE), which is also a wholly owned subsidiary of Raymond James Financial, Inc. Notwithstanding the fact that principals and associates of the advisor may be registered representatives of RJFS, the advisor is solely responsible for investment advice rendered. Advisory services are provided separately and independently of the broker/dealer.

Arnold Weitz does receive commissions, bonuses, and other compensation based on the sale of securities; including trails from mutual funds. This could, but does not give the supervised person an incentive to recommend investment products based on compensation rather than the clients needs.

Other investments may be transferred in or bought and sold in the clients account but not charged an advisory fee. These investments are referred to as "Fee Exempt Investments". These fee exempt investments may include new or secondary offerings including brokered certificates of deposit. Should the client buy these types of securities they will pay a commission which is defined by the terms of the offering and stated in a prospectus or confirmation for the security. These investments will be excluded from the asset value of the clients managed account for a period of 12 months from the time of purchase.

Arnold Weitz operates an LLC that receives rental income from the property that Arnold Weitz & Company currently occupies.
