E-mail correspondence and fees of Vision Advisors Affiliated Person's is reviewed on a regular basis. Steven Silver is the Chief Compliance Officer and the Chief Operating Officer for Vision Advisors and is responsible for supervision of all Independent Marketing Representatives and Investment Advisors Representatives and is located at Vision Advisors Main office at 4 High Ridge Park, Stamford CT, 06905.
