Item 2- Educational Background and Business Experience

C. Wesley (Wes) Gardner, Jr. (CRD# 4931333), born in 1946, is a professional tax consultant specializing in individual and small business taxation. The owner of his own tax practice, Wes provides tax consulting services to Seascope's principals so they may better serve their clients.

As a 1968 graduate of Holy Cross College, Wes began his career in the tax department of what was then Touche Ross & Company. He joined Tyco International in 1973 where he served first as the Regional Tax Manager where he was responsible for all tax attributes of Tyco's eastern subsidiaries. He was subsequently promoted to the position of Assistant Director of Taxation in which he was responsible for filing federal consolidated corporate income tax returns and all applicable state income tax returns.
