Item 2 - Educational Background and Business Experience

Jeremy Griffiths was born in London, England on March 1948. After high school, Mr. Griffiths attended Exeter University from 1966 to 1969 and gained an honors degree in chemical engineering. After university, Mr. Griffiths joined a London-based firm of Chartered Accountants and in 1972, after passing the required examinations, became an Associate of the Institute of Chartered Accountants of England and Wales. In 1975, after practicing as a Chartered Accountant for three years, Mr. Griffiths became a Fellow of the Institute of Chartered Accountants of England and Wales.

Mr. Griffiths has held many senior financial and business roles in international publishing companies both in the UK and the US. From 1997 to 2002 Mr. Griffiths was Chief Financial Officer and Executive Vice President of OppenheimerFunds Inc. From 2005 to 2011 Mr. Griffiths was a managing director of Groton Partners LLC, a boutique investment banking firm.

Nicholas Prouty was born in 1967 and is a graduate of the Claremont Colleges (Pitzer). From 2008 to 2010 Mr. Prouty was a Partner of HudsonCross Financial. Prior to that, from 2001 to 2007 Mr. Prouty worked at Windmill Management and was a Managing Partner of Watson Investments from 1999 to 2001. Mr. Prouty is the co-founding board member of the Habitat Support Foundation.
