Meridian professionals who effect transactions for advisory clients may receive transaction or commission compensation from PKS. The recommendation of securities transactions for commission creates a conflict of interest in that Meridian is economically incented to effect securities transactions for clients. Although Meridian strives to put its clients' interests first, such recommendations may be viewed as being in the best interests of Meridian rather than in the client's best interest. Meridian advisory clients are not compelled to effect securities transactions through PKS.
