ITEM 4 – ADVISORY BUSINESS

<p>Item 4.A</p>	<p><i>Describe your advisory firm, including how long you have been in business. Identify your principal owner(s).</i></p> <p><u>MOAB PARTNERS</u></p> <p>Moab Partners was founded in January 2006 and became registered with the SEC as an investment adviser on March 4, 2011. Moab Partners provides discretionary investment advisory services to two private investment funds as follows:</p> <ul style="list-style-type: none"> ○ A Delaware limited partnership (the “Master Fund”) ○ A British Virgin Islands business company (the “Offshore Feeder”) <p>Each of the Offshore Feeder and the Master Fund may be referred to individually in this Brochure as a “Fund” and together as the “Funds”. The Funds operate as a mini-master-feeder such that the Offshore Feeder invests substantially all of its assets into the Master Fund. In addition, investments may also be made directly into the Master Fund.</p> <p>In addition, Moab Partners provides discretionary investment advisory services to separately managed accounts (the “Managed Accounts” and together with the Funds, the “Moab Advisory Clients”).</p> <p>The owners of Moab Partners are Michael M. Rothenberg (sole Managing Member) and David A. Sackler (passive owner). Moab Partners has a staff of five investment professionals in sum.</p> <p>An affiliate of Moab Partners, Moab GP, LLC (the “General Partner”), serves as general partner to the Master Fund.</p> <p><u>MPI</u></p> <p>MPI was founded in January 2015, and provides discretionary investment advisory services to separately managed accounts (the “MPI Managed Accounts”) and the Moab Select Series (the “Moab Select Series or the “Moab IDF”, and together with the MPI Managed Accounts, the “MPI Advisory Clients”) of the SALI Multi-Series Fund, L.P. (the “SALI Fund”). MPI is managed and operated solely by Michael Rothenberg, the Managing Member of Moab Partners, and is a relying adviser to Moab Partners under the No-Action Letter.</p> <p>Together, Moab Partners and MPI provide investment advisory services to the Moab Advisory Clients and the MPI Advisory Clients (collectively, the “Advisory Clients”).</p>
<p>Item 4.B</p>	<p><i>Describe the types of advisory services you offer. If you hold yourself out as specializing in a particular type of advisory service, such as financial planning, quantitative analysis, or market timing, explain the nature of that service in greater detail. If you provide investment advice only with respect to limited types of investments, explain the type of investment advice you offer, and disclose that your advice is limited to those types of investments.</i></p> <p><u>MOAB PARTNERS</u></p> <p>Moab Partners generally has broad and flexible investment authority with respect to the Moab Advisory Clients.</p>

With respect to the Funds, using the mini-master-feeder structure as described in Item 4.A above, Moab Partners' investment objective is to generate superior risk adjusted returns, or *alpha*, by identifying attractive investment opportunities based on valuation, cash flow yields and events which can be expected to lead to significant current income and/or capital appreciation. The Master Fund seeks to make investments that have asymmetric risk-return profiles, possessing greater upside potential than downside risk. These investments may include, but are not limited to, common and preferred equity securities; bonds, notes, and debentures (all primarily distressed); bank debt (distressed or not distressed); swaps and options. Michael M. Rothenberg serves as portfolio manager of the Master Fund (the "Portfolio Manager"). The Portfolio Manager will allocate a varying percentage of the Master Fund's assets between: (1) event driven investment opportunities in different asset classes and industries with capital appreciation and/or current income opportunities; and (2) non-distressed corporate credit opportunities offering current income but little or no capital appreciation depending on market conditions and the absolute attractiveness of the event driven investment opportunities identified by Moab Partners' investment professionals. Often, the Master Fund will invest in companies with complicated capital structures.

When appropriate, the Portfolio Manager or other Moab Partners investment professionals will take activist roles, typically in concert with parallel holders, to maximize the intrinsic value of a security in the portfolio. The Portfolio Manager and other Moab Partners investment professionals have experience in these situations and have been actively involved in recapitalizations, restructurings, and private placements, in formal committees or on an *ad hoc* basis, to achieve the optimal outcome for certain of their previous investments.

The Portfolio Manager may, in his discretion, cause the Master Fund to invest in a wide variety of additional securities and other investments. The Master Fund's governing documents do not limit the types of positions the Master Fund may take, the concentration of its investments (by country, sector, industry, capitalization, company, or asset class), or the number or extent of its short positions. The Partnership Agreement of the Master Fund permits a wide range of investments, including not only common stocks and options, but also other related derivative instruments, preferred stocks, and cash equivalents.

It should be noted that the Managed Accounts' investment objectives and the types of investments that such portfolio will hold are individually negotiated and established between Moab Partners and the Managed Accounts.

MPI

MPI provides investment advice to the MPI Managed Accounts regarding the investment of the MPI Managed Accounts into the preferred equity securities of a private fund managed by an unaffiliated third-party which invests in certain healthcare-related real-estate development projects (the "Development Fund"). MPI also provides the MPI Managed Accounts with ongoing monitoring of their investments. In addition, MPI acts as an investment sub-adviser with respect to the Moab IDF, which is an insurance-dedicated fund ("IDF"). IDFs can be accessed via a private placement variable annuity investment account or a private placement variable universal life investment account.

<p>Item 4.C</p>	<p><i>Explain whether (and, if so, how) you tailor your advisory services to the individual needs of clients. Explain whether clients may impose restrictions on investing in certain securities or types of securities.</i></p> <p><u>MOAB PARTNERS</u></p> <p>With respect to the Funds, Moab Partners neither tailors its advisory services to the individual needs of investors in the Funds (“Investors”), nor accepts Investor-imposed investment restrictions. In the case of the Managed Accounts, Moab Partners has tailored the investment objectives/restrictions of the Managed Accounts and has individually negotiated the terms and fees for the Managed Accounts, which may be different from those of the Funds. It should be noted that investment objectives, fee arrangements and terms for any future managed account relationships will be similarly individually negotiated.</p> <p>Moab Partners has in the past entered into side letter agreements with certain large and strategic Fund Investors that provide such Investors with fee discounts. In the future, Moab Partners may enter into additional side letter agreements which may allow for additional notification rights, special redemption or withdrawal rights relating to frequency, and greater transparency, among others.</p> <p><u>MPI</u></p> <p>With respect to the MPI Managed Accounts, MPI negotiated the terms of the investment of the MPI Managed Account assets into the Development Fund based on the MPI Managed Accounts’ investment objectives, preferred return, yield protection and other financial covenants and restrictions with respect to their investment. MPI has also entered into investment management agreements (“MPI Advisory Agreements”) with certain MPI Managed Accounts that provide for special fee provisions and certain notification rights. With regard to the Moab IDF, MPI neither tailors its advisory services to the individual needs of investors, nor accepts Investor-imposed investment restrictions. Policy owners do not have the right to communicate with or direct the investment policies or decisions of MPI relating to the Moab IDF.</p>

Disclose the date “as of” which you calculated the amounts.</i></p> <p>As of December 31, 2014, Moab Partners manages approximately \$553,748,000 of client regulatory assets on a discretionary basis. Moab Partners does not currently manage any client assets on a non-discretionary basis.</p> <p>As of December 31, 2014, MPI does not manage any assets, but expects to manage \$50.2 million of client regulatory assets on a discretionary basis.</p>

Disclose whether the fees are negotiable.</i></p> <p><u>MOAB PARTNERS</u></p> <p>Moab Partners typically charges fees that are based upon a set percentage of assets under management and performance. Set forth below are summaries of the fees payable by Investors in the Funds. It should be noted that detailed disclosure about the fees and other expenses applicable to an investment in the Funds is provided in the operative documents for the applicable Fund. Those operative documents should be carefully reviewed prior to making an investment in the Funds.</p> <p>Investors in the Funds are typically charged a Management Fee equal to approximately 1.5% to 2% per annum, based on class of shares or interests, of the amount invested in a particular Fund, payable monthly in arrears.</p> <p>Investors in the Funds are also typically charged an Incentive Fee/Performance Allocation equal to 20% per annum of the net profits allocable to the amount invested in a particular Fund.</p> <p>The Management Fee and Incentive Fee/Performance Allocation are negotiable in that Moab Partners reserves the right to reduce, waive or calculate differently such fees for certain Investors. In particular, principals, employees and certain affiliates of Moab Partners currently invested in the Funds are not charged a Management Fee or an Incentive Fee/Performance Allocation.</p> <p>It should be noted that the Managed Accounts may be subject to different terms and fees as such fee arrangements and terms are individually negotiated between Moab Partners and the Managed Accounts.</p> <p><i>It is critical that Investors refer to their respective Fund’s governing documents for a complete understanding of how Moab Partners is compensated for its advisory services. The information contained herein is a summary only and is qualified in its entirety by the relevant Fund governing documents.</i></p> <p><u>MPI</u></p> <p>MPI Managed Accounts: Following the return of all capital contributions by the MPI to the Development Fund, MPI generally receives a portion of each MPI Managed Accounts’ distributions from the Development Fund thereafter as an advisory fee (the “MPI Advisory Fee”) equal to 15% of net cash flow and capital proceeds of the Development Fund otherwise distributed to the MPI Managed Accounts.</p> <p><i>It is critical that MPI Managed Account holders refer to their respective MPI Advisory Agreements for a complete understanding of how MPI is compensated for its advisory services. The information contained herein is a summary only and is qualified in its entirety by the relevant MPI Advisory Agreements.</i></p>

	<p>Moab IDF:</p> <p>MPI typically charges fees that are based upon a set percentage of assets under management and performance. Set forth below are summaries of the fees payable by Investors in Moab IDF. It should be noted that detailed disclosure about the fees and other expenses applicable to an investment in the Moab IDF is provided in the operative documents for the fund. Those operative documents should be carefully reviewed prior to making an investment in Moab IDF.</p> <p>Investors in the Moab IDF are typically charged a Management Fee that ranges from approximately 1.65% to 2.15% per annum, of the amount invested in the fund, payable on the first of each month.</p> <p>Investors in the Moab IDF are also typically charged an Incentive Fee equal to 20% per annum of the net profits allocable to the amount invested in the fund.</p> <p>The Management Fee and Incentive Fee/Performance Allocation are negotiable in that SALI Fund Partners, LLC, the General Partner of the Moab IDF, reserves the right to reduce, waive or calculate differently such fees for certain Investors.</p>

Explain how often you bill clients or deduct your fees.</i></p> <p><u>MOAB PARTNERS</u></p> <p>Moab Partners (or an affiliate) deducts fees from the Funds' assets and such fees are calculated by the Funds' administrator.</p> <p>The Funds charge an asset-based Management Fee equal to approximately 1.5%-2% per annum, based on the class of shares or interests, of the amount invested in a particular Fund as of the last business day of a calendar month (prior to the accrual of any Incentive Fee/Performance Allocation and any redemptions or withdrawals as of such last business day). Such fee is typically paid monthly in arrears. The Management Fee is prorated for amounts held for less than a full calendar month.</p> <p>The Funds also charge an annual performance-based Incentive Fee/Performance Allocation equal to 20% of the appreciation in each Investor's account balance during the year. The Incentive Fee/Performance Allocation is calculated and charged separately with respect to each Investor and/or class of shares or interests within each client Fund. If an Investor redeems or withdraws all or a portion of its capital account on a date other than December 31, an Incentive Fee/Performance Allocation will be made on the amount redeemed or withdrawn for the period since the prior January 1, and any applicable Management Fee will be deducted from the amount redeemed or withdrawn for the period from the preceding month end to the date of redemption or withdrawal.</p> <p>Moab Partners and/or the General Partner, in their sole discretion, may, in effect, waive or reduce the Management Fee and/or the Incentive Fee/Performance Allocation to be paid by Investors for any reason.</p> <p>The Managed Account relationships are subject to terms that are individually negotiated between Moab Partners and the Managed Accounts. A complete description of all fees, the methods of billing and how often such fees are charged for the Managed Accounts is disclosed within the investment management agreements entered into by Moab Partners and the Managed Accounts.</p> <p><u>MPI</u></p> <p>MPI Managed Accounts: MPI receives the MPI Advisory Fee directly from the Development Fund. No fees are deducted from or invoiced to the MPI Managed Accounts.</p> <p>Moab IDF: MPI deducts fees from the Fund's assets and such fees are calculated by the Fund's administrator.</p> <p>Investors in Moab IDF are typically charged a Management Fee equal to approximately 1.65% to 2.15% per annum, of the amount invested in the fund, payable on the first business day of each month. The Management Fee is prorated for amounts held for less than a full calendar month.</p> <p>Investors in Moab IDF are also typically charged an Incentive Fee equal to 20% per annum of the net profits allocable to the amount invested in the fund.</p>

The Management Fee and Incentive Fee/Performance Allocation are negotiable in that SALI Fund Partners, LLC reserves the right to reduce, waive or calculate differently such fees for certain Investors.</p>

Disclose that clients will incur brokerage and other transaction costs, and direct clients to the section(s) of your brochure that discuss brokerage.</i></p> <p><u>MOAB PARTNERS</u></p> <p>Each Fund pays all of its operation expenses.</p> <p>Offshore Feeder expenses include any fees, costs or expenses the Offshore Feeder, Moab Partners or their affiliates reasonably incur in connection with the operation of the business and maintenance of the Offshore Feeder. Such expenses include but are not limited to: (a) the Management Fee and the Incentive Fee; (b) U.S. federal, state and local taxes, filing and registration fees of the Offshore Feeder, Moab Partners and their affiliates (other than taxes on the income of the Moab Partners and their affiliates); (c) all costs, fees and expenses relating to shareholder communications and relations, accounting and the preparation and mailing of financial, tax and performance information to shareholders, including an allocable share of Moab Partners' costs, fees and expenses relating to internal accounting and tax preparation functions should the Offshore Feeder determine to use third party providers for such services; (d) fees, costs and expenses incurred in connection with Offshore Feeder borrowings; (e) Offshore Feeder administration fees, costs and expenses; (f) taxes, fees, costs and expenses incurred by the Offshore Feeder, Moab Partners or their Affiliates in connection with compliance with the Foreign Account Tax Compliance Act; (g) fees, costs and expenses incurred in connection with the registration of Moab Partners pursuant to the Advisers Act as well as ongoing compliance requirements; (h) fees for attorneys, auditors, consultants and other professionals or experts, including compliance consultants; (i) costs and expenses incurred for the purpose of protecting and enhancing the value of the assets of the Master Fund (including the costs of instituting and defending litigation); (j) premiums and other costs of D&O/E&O and other insurance; and (k) directors' fees.</p> <p>Master Fund expenses include but are not limited to all of the above and all fees, costs and expenses that are incurred in connection with actual and potential Master Fund investments, such as: (a) any management fee payable by the Master Fund to Moab Partners and the Incentive Fee; (b) brokerage and execution charges, commissions, custodial charges, and fees for quotation and other data services; (c) fees related to accounting, trading, portfolio management and risk management systems; (d) research subscriptions and expenses; (e) legal and consulting fees related to investment research; (f) broken deal fees; and (g) expenses to register securities and transfer taxes.</p> <p>Moab Partners and/or the General Partner may at its discretion choose to reimburse the Funds for all or any portion of their expenses.</p> <p>Moab Partners is responsible for its own general operating and overhead costs including salaries, employee benefits, office rent and other general overhead costs.</p>

Please note that Investors will indirectly incur brokerage and other transaction costs related to their investment in the Funds. Please see Item 12 of this brochure for a more detailed discussion of Moab Partners' brokerage practices.

It should be noted that a complete description of all fees and expenses for the Funds and the Managed Accounts is disclosed within the respective Funds' operative documents and in the Managed Accounts' investment management agreements.

MPI

In addition to the expenses related to their investment in the Development Fund, MPI Managed Accounts are responsible for (i) the costs and expenses incurred by MPI, capped at a total of \$200,000, in evaluating, negotiating and monitoring the MPI Managed Accounts' investment in the Development Fund; and (ii) the costs and liabilities incurred by MPI as a result of any other actions taken by MPI designed to protect the MPI Managed Accounts' investments in the Development Fund or other related expenses. The above-listed expenses, costs and liabilities are described in more detail in the Development Fund's operating agreement (the "Development Fund Agreement") and the MPI Advisory Agreement.

The Moab IDF is subject to certain expenses as detailed in the SALI Confidential Private Offering Memorandum, the Moab Select Series Supplement to the Confidential Private Offering Memorandum of SALI Multi-Series Fund, L.P. and the SALI Limited Partnership Agreement ("SALI Legal Documents"), including, but not limited to: (a) all costs and expenses directly related to investments or prospective investments of the SALI Fund, including fees of professional advisors, consultants and finders relating to investments or prospective investments; (b) brokerage commissions and other transaction costs; (c) fees related to accounting, trading, portfolio management and risk management systems; (d) research subscriptions and expenses; (e) legal fees and expenses for advice directly relating to the SALI Fund's legal affairs, including those related to investment research; (f) broken deal fees; (g) costs and expenses associated with the offering of the SALI Fund; (h) costs and expenses incurred for the purpose of protecting and enhancing the value of the assets of the Moab Select Series (including the costs of instituting and defending litigation); (i) costs of any liability insurance; (j) U.S. federal, state and local taxes, filing and registration fees of the Moab Select Series, Moab and its affiliates and any withholding or transfer taxes imposed on the SALI Fund or any of its partners; (k) all costs and expenses associated with reporting and providing information to existing and prospective investors; (l) expenses related to proxies and underwriting, interest and commitment fees on debit balances or borrowings, custody fees; (m) any governmental, regulatory, licensing, filing or registration fees incurred in compliance with the rules of any self-regulatory organization or any federal, state or local laws; (n) audit costs, fees and expenses for financial and tax accounting and reporting services and administrative services on behalf of the SALI Fund; and (o) organizational costs.

MPI or its affiliate (Moab Partners) will bear its own operating and overhead expenses attributable to the management of the Moab IDF (such as salaries, bonuses, rent, office and administrative expenses, and depreciation and amortization).

It should be noted that a complete description of all fees and expenses for the Moab IDF is disclosed within the SALI Legal Documents.

<p>Item 5.D</p>	<p><i>If your clients either may or must pay your fees in advance, disclose this fact. Explain how you will determine the amount of the refund.</i></p> <p><u>MOAB PARTNERS</u></p> <p>Neither the Management Fee nor the Incentive Fee/Performance Allocation is paid in advance.</p> <p>Investors generally are able to redeem from the Funds as of the end of any calendar quarter upon at least 60-90 days' prior written notice (as specified in the relevant Fund's governing documents and based on the class of shares or interests). In each case, redemptions or withdrawals will be subject to significant conditions and restrictions, which are set forth in the relevant Fund's governing documents. Such conditions, restrictions, and limitations may include, without limitation:</p> <ul style="list-style-type: none"> • The condition that redemption or withdrawal requests be properly submitted in accordance with the relevant Fund documents and in a timely manner; • The condition that any "lock-up period" or "penalty period" applicable to the shares or interests has expired or relevant redemption or withdrawal fee has been paid; • The condition that any minimum holdings amounts have been satisfied; • The condition that redemptions or withdrawals, the calculation of net asset value, or the ability of Investors to redeem or withdraw have not been suspended (in whole or in part); • Restrictions on the amount that may be redeemed or withdrawn; • Restrictions on the timing of redemption or withdrawal payments; • Limitations on the amount paid to a redeeming or withdrawing Investor due to hold backs or reserves for certain expenses, Fund liabilities, and contingencies, among others; and • Limitations on the method of redemption or withdrawal payments (i.e., in cash or in kind). <p>The Funds' Class A shares or interests are subject to a one-year initial soft lock-up period (a "penalty period") and the Class B shares or interests are subject to a soft two-year rolling lock-up (a "penalty period") whereby Class B investors are permitted to make withdrawals only biennially on each two-year anniversary of the date on which such investor's capital account was established.</p> <p>During the "penalty period," if the investor is permitted to withdraw any portion prior to the expiration of the penalty period, the investor pays an early withdrawal fee ranging from 3-5%. As described in Item 5.A above, the Moab Partners General Partner receives performance-based compensation in the form of an Incentive Fee/Performance Allocation. MPI receives a portion of the distributions otherwise made to the MPI Managed Accounts from the Development Fund and MPI also receives performance-based compensation in the form of an Incentive Fee for the Moab IDF. While each Advisory Client managed by the Advisers pays performance-based compensation, it should be noted that the Advisers reserve the right to reduce, waive or calculate differently such fees for certain Advisory Clients (or in the case of the Funds, the Investors).

Managed accounts are subject to performance-based fees, which are individually negotiated, that differ from those payable by Investors in the Funds. It should also be noted that the possibility that Moab Partners or MPI (or an affiliate of Moab Partners) may receive performance-based compensation creates a potential conflict of interest in that it may create an incentive to make investments that are riskier or more speculative than in the absence of such a performance-based fee.

Advisory Clients are provided with clear disclosure as to how performance-based compensation is charged with respect to a particular fund/account and the risks associated with such performance-based compensation prior to making an investment.

Moab Partners and MPI recognize that they are fiduciaries and as such must act in the best interests of all of their Advisory Clients. Further, Moab Partners and MPI recognize that they must treat all Advisory Clients fairly and must refrain from favoring one Advisory Client's interests over another's.

MOAB PARTNERS

Moab Partners provides investment advisory services to pooled investment vehicles operating as private investment funds as well as an institutional separately managed account client.

The fee arrangements and investment terms of the Managed Accounts have been individually negotiated. The minimum initial contribution to the Moab Funds is \$2,000,000, subject to reduction at the discretion of Moab Partners or an affiliate. Additional contributions to the Moab Funds must be at least \$1,000,000, also subject to reduction at the discretion of Moab Partners or an affiliate.

MPI

MPI provides investment advisory services to the individual and institutional separately managed account clients under the terms of the MPI Advisory Agreements. The investments for the MPI Managed Accounts are individually negotiated and subject to the discretion of MPI.

Investors in the Funds and MPI Managed Accounts must generally be “accredited investors” within the meaning of Regulation D under the Securities Act of 1933, as amended and “qualified clients” as defined in Rule 205-3 under the Investment Advisers Act of 1940, as amended.

Further, MPI provides investment advisory services to the Moab IDF. The minimum initial contribution to the Moab IDF is \$2,000,000, subject to reduction at the discretion of SALI Fund Partners, LLC.

ITEM 8 – METHODS OF ANALYSIS, INVESTMENT STRATEGIES AND RISK OF LOSS

Explain that investing in securities involves risk of loss that clients should be prepared to bear.</i></p> <p><u>MOAB INVESTMENT STRATEGIES AND METHODS OF ANALYSIS</u></p> <p>The Master Fund seeks to make investments that have asymmetric risk-return profiles, possessing greater upside potential than downside risk. These investments may include, but are not limited to, common and preferred equity securities, bonds, notes, debentures, loans, swaps and options. The Portfolio Manager will allocate a varying percentage of the Master Fund’s assets between (1) event driven investments in different asset classes and industries with capital appreciation and/or current income opportunities; and (2) non-distressed corporate credit opportunities offering current income but little or no capital appreciation; depending on market conditions and the absolute attractiveness of the event driven investment opportunities identified by the Portfolio Manager (subject to position size limitations).</p> <p>The Portfolio Manager believes this mix of investments will allow the Master Fund to reduce the volatility of returns and generate significant <i>alpha</i> in all market environments. Furthermore, the Portfolio Manager believes that the ability of the Master Fund to invest in non-distressed corporate bank debt for current income assures that the rigorous standards each investment is held to will not be compromised by a need to deploy capital.</p> <p>When appropriate, the Portfolio Manager or other Moab Partners investment professionals will take activist roles, typically in concert with parallel holders, to maximize the intrinsic value of a security in the portfolio.</p> <p>The methods of identifying opportunities include the Portfolio Manager’s extensive experience and relationships in the event driven sectors the Master Fund will focus on, as well as brokers, advisors, industry contacts, screening software, newsletters, industry publications, news stories, and other sources of information. All methods of idea generation are designed to produce a set of investments with attractive valuation and cash flow profiles as well as identifiable events that will lead to a substantial change in market valuation and/or attractive current income.</p> <p>The Master Fund maintains strict standards of due diligence once an idea has been generated. These include, but are not limited to, meetings with management, detailed financial modeling, checks with customers and competitors, proprietary market surveys, and on-site visits. Short positions are approached with the same diligence and research-intensive model as long investments. Position size is in part determined by the ability of the Master Fund to gain an information edge relative to the broader market through extensive research on a position. Position size is also dictated by the Master Fund’s risk management parameters.</p> <p>Often the Master Fund will invest in companies with complicated capital structures. Investment opportunities in such companies will be evaluated tranche by tranche throughout the capital structure, comparing the upside and downside characteristics of each tranche of debt and equity as well as identifying possible pair-trade or arbitrage</p>

opportunities. For stressed and distressed companies, the Portfolio Manager will evaluate the “fulcrum” tranche which is likely to own the future equity of the company in the event of a recapitalization or restructuring and consider the attractiveness of the “fulcrum” for investment.

In some situations, the Portfolio Manager will evaluate securities being sold or purchased by certain investment institutions for structural reasons such as credit rating changes, stock indexing or de-indexing, or a company’s filing for bankruptcy protection. The Portfolio Manager will seek to exploit these market dynamics that may cause securities to trade at prices dramatically different from their intrinsic value.

The Master Fund will also attempt to exploit a large portion of the investment industry’s dependence on EBITDA (Earnings Before Interest, Taxes, Depreciation and Amortization expenses) as a proxy for true cash flow. Moab Partners’ investment professionals will endeavor to understand the difference between each investment prospect’s EBITDA and true cash flow and seek to profit from investable opportunities that arise from this diligence.

As the Portfolio Manager intends to focus his energies on fundamental research in individual investments, turnover in the portfolio will be centralized on the achievement of price targets or the change of facts surrounding an investment’s fundamental thesis. Upside and downside price targets will be utilized for each investment in the portfolio, and they will be calculated based on valuation and event parameters. Market movements in established positions that are unexpected will be carefully evaluated as opportunities for trading profits. After an investment’s target position size has been reached, careful maintenance research, continued discussions with company management teams and overall portfolio considerations will be the primary factors in determining when to modify the Master Fund’s exposure to a given investment.

It should be noted that the Managed Accounts’ investment objectives and the types of investments that such portfolio will hold are individually negotiated and established between Moab Partners and the Managed Accounts.

MPI INVESTMENT STRATEGY AND METHODS OF ANALYSIS

MPI Managed Accounts

The MPI Managed Accounts seek to achieve long-term performance returns with some protection against downside risk by investing in the preferred equity securities of the Development Fund. In evaluating the MPI Managed Accounts’ potential investment in the Development Fund, MPI conducted substantial due diligence with respect to the management and operations of the Development Fund, the past development projects completed by the manager of the Development Fund, the real estate projects that the Development Fund has proposed to develop, the sources of financing for those development projects other than the capital contributions of the MPI Managed Accounts, and the terms of those other financing arrangements. In analyzing the underlying investments of the Development Fund, MPI engaged in multiple discussions with the management of the Development Fund regarding the real estate development projects, including the target returns of the fund and the projected timelines, budgets, leasing terms and disposition strategies for each project.

Moab IDF

Moab Select Series invests a substantial portion of its assets in the Moab Funds. MPI allocates a varying percentage of its assets between the following, depending on market

If your primary strategy involves frequent trading of securities, explain how frequent trading can affect investment performance, particularly through increased brokerage and other transaction costs and taxes.</i></p> <p>Both the Moab Advisory Clients managed by Moab Partners and the MPI Advisory Clients managed by MPI pursue an opportunistic investment strategy. Moab Partners has broad flexibility to invest the assets of the Moab Funds in any industry or asset class.</p> <p><u>MOAB ADVISORY CLIENTS</u></p> <p><u>Business Risk</u></p> <p>The Master Fund's investments involve a high degree of risk and may be considered speculative. The Funds are for sophisticated investors who can accept a high degree of risk in their investment, do not need regular current income and can accept a potential loss of their entire investment.</p> <p><u>Discretion of Moab Partners; Concentration of Investments</u></p> <p>There are no limits on the types of positions the Master Fund may take, the size of the companies in which the Master Fund may invest, or the concentration of investments (by sector, industry, capitalization, company, country or asset class). At times, the Master Fund may hold a relatively small number of securities positions, each representing a relatively large portion of the Funds' capital.</p>

Short Sales

The Master Fund may make short sales in any type of securities. Short sales that are not made “against the box” and are not part of a hedging transaction create opportunities to increase return but, at the same time, are speculative and involve special risk considerations. Since the seller in effect profits from a decline in the price of the securities sold short without the need to invest the full purchase price of the securities on the date of the short sale, returns will tend to increase more when the securities sold short decrease in value, and to decrease more when the securities sold short increase in value, than would otherwise be the case if the seller had not engaged in such short sales. Short sales theoretically involve unlimited loss potential, as the market price of securities sold short may continuously increase. Under adverse market conditions the Master Fund might have difficulty purchasing securities to meet its short sale delivery obligations, and might have to sell portfolio securities to raise the capital necessary to meet its short sale obligations at a time when fundamental investment considerations would not favor such sales.

Illiquidity

Some of the securities in which the Master Fund invests may be relatively illiquid, either because they are thinly traded, because they are traded in the over-the-counter market or on a regional exchange, or because they are subject to transfer restrictions. The Master Fund may not be able promptly to liquidate those investments if the need should arise, and its ability to realize gains, or to avoid losses in periods of rapid market activity, may therefore be affected. In addition, the value assigned to such securities for purposes of valuing assets and determining net profits and net losses may differ from the value the Master Fund is ultimately able to realize.

Use of Leverage

The use of leverage by buying securities on margin is a speculative technique that involves special risk considerations. Interest costs on borrowings may fluctuate with changing market rates of interest and may partially offset or exceed the return earned on borrowed funds. Interest on borrowings will be an expense of the Master Fund and will affect the investment performance of the Master Fund. To the extent the Master Fund is leveraged, the value of its assets will tend to increase more when its portfolio securities increase in value, and to decrease more when its portfolio securities decrease in value, than if its assets were not leveraged. The rights of any lenders to the Master Fund to receive payments of interest or repayments of principal will be senior to those of the Investors. Consequently, the Master Fund might have to sell portfolio securities to meet interest or principal payments at a time when fundamental investment considerations would not favor such sales. Also, the terms of any borrowings may contain provisions that limit certain activities of the Master Fund, including the ability to make distributions.

Finally, it is noted that Investors and prospective Investors are provided with a confidential private placement memorandum that contains a detailed description of the material risks related to an investment in the Funds.

It should be noted that the Managed Accounts’ investment objectives and the types of investments that such portfolio will hold are individually negotiated and established between Moab Partners and the Managed Accounts.

MPI MANAGED ACCOUNTS

Illiquidity

There is no existing market for the membership interests of the Development Fund and the interests will not be listed or quoted on any stock exchange or traded in the over-the-counter market. The interests are not being registered under federal or state securities laws and may not be transferred except with the consent of the MPI and the manager of the Development Fund subject to the terms and conditions in the Development Fund Agreement.

Management's Discretion

The Development Fund Agreement permits capital contributions to be allocated to the start-up costs and ongoing expenses of Development Fund including, but not limited to, the costs associated with the evaluation, acquisition, financing or disposition of development projects, sales commissions, appraisal fees, taxes, brokerage fees, underwriting commissions and discounts, and legal, accounting, investment banking, consulting, information services and professional fees. Except as otherwise provided in the Development Fund Agreement, this provides the fund manager with broad discretion over the use of all capital contributions to Development Fund.

No Withdrawals Permitted

Under the terms of the Development Fund Agreement, investors are not entitled to withdraw any of their investment in Development Fund. Returns, if any, are in the form of distributions of net cash flow derived from the development projects and net proceeds from the sale of the development projects, to the extent available.

MOAB IDF

In addition to the risks disclosed with regard to the Moab Funds above, the following risks are of note:

Concentration of Investments.

Limits are not imposed on the types of positions the Moab IDF may take, the size of the companies in which the Moab IDF may invest, or the concentration of its investments (by sector, industry, capitalization, company, country or asset class). MPI will attempt to spread the Moab Select Series' capital among a number of investments, however, at times the Moab IDF may hold a relatively small number of securities positions, each representing a relatively large portion of the Moab Select Series' capital. Losses incurred in such positions could have a material adverse effect on the Moab Select Series' overall financial condition.

Potential Conflicts of Interest.

MPI will endeavor to ensure that any conflicts of interest are resolved fairly. Because MPI and other principals and/or employees of MPI may engage in other securities investment activities and businesses, including the management of trading accounts on their own behalf, conflicts of interest may arise among the Moab Select Series and these persons. MPI's or Moab's other clients may compete with the Moab Select Series for the same investment opportunities, which may be limited. MPI is not obligated by contract to buy, sell or recommend for the Moab Select Series any security or other investment that may be bought, sold or recommended for other clients, but MPI will fairly allocate the investment opportunity or ability to dispose of the investment in the event of an actual conflict.

	<p>MPI may recommend trades for such other persons that are different from trading decisions made on behalf of the Moab Select Series. In addition, MPI and its officers and employees may trade certain securities for their own accounts, provided that they do so in accordance with MPI's personal trading activities policy.</p>

If the type of security involves significant or unusual risks, discuss these risks in detail.</p> <p>MOAB ADVISORY CLIENTS & MOAB IDF</p> <p><u>Equities</u></p> <p>The Master Fund's investment portfolio may include positions in common and preferred stocks of U.S. and non-U.S. issuers. Equity securities fluctuate in value in response to many factors, including the activities and financial condition of individual companies, the business market in which individual companies compete and industry market conditions and general economic environments.</p> <p><u>Bonds</u></p> <p>The Master Fund may invest in non-performing, "distressed" debt – high yield bonds issued by entities that have already indicated an inability to pay outstanding interest or principal. These securities often are contractually or structurally subordinated in right of payment to prior claims of banks or other senior lenders, and will typically be unsecured. Often the ability to sell these securities at their fair value either to meet redemption requests or to respond to changes in the financial markets may be limited.</p> <p><u>Corporate Debt Securities</u></p> <p>The Master Fund also invests in corporate debt securities, including obligations of varying maturities (such as debentures, bonds and notes). If the Master Fund has to sell the debt security before the maturity date, an increase in interest rates will result in a loss. Interest on debt securities may be at fixed, variable or floating rates. The Fund may invest without limitation in debt securities rated below "Baa" by Moody's Investor Services, Inc. or "BBB" by Standard & Poor's Corporation or below investment grade by other recognized rating agencies, or in unrated securities. Lower rated securities are speculative and may be in default. The Master Fund may also invest in loans and other direct debt instruments that are interests in amounts owed to another party by a company or other borrower. Debt securities acquired by the Master Fund may include securities with contractual or legal restrictions on resale to the general public, but that may be sold to institutional buyers in accordance with Rule 144A under the Securities Act.</p> <p><u>Derivative Instruments</u></p> <p>Moab Partners may use various derivative instruments, including futures, options, forward contracts, swaps and other derivatives that may be volatile and speculative. The use of derivatives involves risks different from, or possibly greater than, the risks associated with investing directly in securities or more traditional investments, depending upon the characteristics of the particular derivative and the Master Fund's portfolio as a whole. Derivatives permit the Master Fund to increase or decrease the level of risk of its portfolio, or change the character of the risk to which its portfolio is exposed, in much the same way as the Master Fund can increase or decrease the level of risk, or change the character of the risk, of its portfolio by making investments in specific securities. Derivatives may entail investment exposures that are greater than their cost would suggest, meaning that a small investment in derivatives could have a large potential impact on the Master Fund's performance. If the Master Fund invests in</p>

	<p>derivatives at inopportune times or judges market conditions incorrectly, such investments may lower the Master Fund's return or result in a loss. The Master Fund also could experience losses if derivatives are poorly correlated with its other investments, or if the Master Fund is unable to liquidate its position because of an illiquid secondary market. The market for many derivatives is, or suddenly can become, illiquid. Changes in liquidity may result in significant, rapid, and unpredictable changes in the prices for derivatives.</p> <p>It should be noted that the Managed Accounts' investment objectives and the types of investments that such portfolio will hold are individually negotiated and established between Moab Partners and the Managed Accounts.</p> <p><u>MPI MANAGED ACCOUNTS</u></p> <p><u>Investments are Subordinate to All Debt Financing</u></p> <p>The real estate projects developed by the Development Fund will be partially funded by bank loans and other debt financings. Accordingly, the return of the MPI Managed Accounts' capital contributions and preferred return distributions from the Development Fund will be subordinated in right to payment to all loans and other debt financings with respect to the development projects, including mezzanine loans and constructions loans. Under the Development Fund Agreement, the development projects are limited in the amount of senior debt they can incur based on a maximum loan-to-cost percentage on an individual and aggregate basis. To exceed these limits, the manager of the Development Fund must seek the approval of MPI. Despite these limitations, there can be no guarantee that the MPI Managed Accounts will receive any distribution in the event of a liquidation of the development projects for any reason.</p> <p><u>Financing Guarantees May Exceed the Value of Investors' Investment</u></p> <p>The Development Fund may be obligated, if expressly requested by a senior lender, to co-guarantee the payment of certain obligations under the debt financing arrangements to fund the development projects. 	<p><u>Real Estate Ownership Risks</u></p> <p>The Development Fund and its subsidiaries intend to sell all development projects to a third party upon the completion of construction and the commencement of the applicable lease. In the event that this third party determines not to purchase a property, and in the event the Development Fund or its subsidiaries cannot find another purchaser or determine to hold the developed property for a period of time, the investors will be subject to many risks that are associated with the ownership of real estate, including: general liability, property and casualty losses, some of which may be uninsured, the inability to sell the developed properties on terms acceptable to MPI and the manager of the Development Fund, the leases not being renewed or renewed at lower rental amounts at expiration, default by operators, environmental hazards, and acts of God or terrorism affecting the property. Investors should carefully review the audited financial statements of the Funds.

Moab Partners is of the view that it does not have custody over the cash or securities of the Managed Accounts.

MPI

MPI does not have custody over the cash or securities of the MPI Managed Accounts or the Moab IDF.

Moab Partners has discretionary authority to manage the portfolios of the Advisory Clients. Moab Partners is authorized to make purchase and sale decisions for its Advisory Clients.

In the case of the Funds, as explained above, each Fund's investment strategy is set forth in detail in such Fund's confidential private offering memorandum or explanatory memorandum. Investors do not have the ability to impose limitations on Moab Partners' discretionary authority. Prospective Investors are provided with a confidential private offering memorandum prior to their investment and are encouraged to carefully review such confidential private offering memorandum, along with all other relevant Fund materials, and to be sure that the proposed investment is consistent with their investment goals and tolerance for risk. Prospective Investors should also consult with their legal, tax, or other advisors prior to making any investment. Prospective Investors must also execute a subscription agreement, in which they make various representations, including representations regarding their suitability to invest in a high-risk investment pool. Further, prospective Investors in the Master Fund must execute a limited partnership agreement.

In the case of the Managed Accounts, Moab Partners has tailored the investment objectives to the specific objectives/restrictions of the Managed Accounts and has individually negotiated the terms and fees for the Managed Accounts, which are different from those of the Funds. Moab Partners obtained discretionary authority over the Managed Accounts through investment management agreements with the Managed Accounts.

MPI

Under the MPI Advisory Agreements, MPI has discretionary authority to manage each MPI Managed Account's investments in the Development Fund. The terms of the MPI Advisory Agreements provide MPI with an irrevocable proxy and power of attorney to act on behalf of the MPI Managed Accounts in connection with their investment in Development Fund. While MPI has approval rights under the Development Fund Agreement with respect to certain major decisions of the Development Fund, MPI primarily monitors the MPI MPI Managed Accounts' investments and seeks to protect the investments of MPI Managed Accounts in Development Fund, which may include compelling the Development Fund to sell all or a portion of its properties and other assets and distribute the proceeds to the MPI Managed Accounts.

Under the SALI Legal Documents, MPI has discretionary authority to manage the Moab IDF's investments in the SALI Fund. The Moab IDF's investment strategy is set forth in detail in the SALI Legal Documents. As noted in Item 4.C, investors in the Moab IDF do not have the ability to impose limitations on MPI's discretionary authority. Prospective Investors are provided with the Moab Select Series Supplement to the Confidential Private Placement Memorandum for the SALI Fund prior to their investment and are encouraged to carefully review such confidential private offering memorandum, along with all other relevant fund materials, and to be sure that the proposed investment is consistent with their investment goals and tolerance for risk. Prospective Investors should also consult with their legal, tax, or other advisors prior to making any investment. Prospective Investors must also execute a subscription agreement, in which they make various representations, including representations regarding their suitability to invest in a relatively illiquid investment. Prospective investors should consider a subscription only if they do not anticipate any short term need for their funds.
