The firm utilizes reports provided by RBC Dain for fee based portfolio review which include the clients program selection, portfolio objective and account risk level and reviewed periodically. All trades are reviewed by reviewing the daily blotters which include the advisory and managed account trades for any irregularities and negative trading activity.
