Mr. Justin Boshnack born 1978 holds a Bachelor of Science degree in Finance. Mr. Boshnack currently works as an Investment Advisor Representative with Vision Investment Advisors ("VIA"). He is also the president and owner of Three Lakes Trading Company, Inc. and managing member at JLC Futures Management Company LLC. He is also a principal of Luke Asset Management Partners LLC. He currently holds FINRA series 66 and 65 licenses.

Item 3. Disciplinary Information

Mr. Boshnack does not have any disciplinary information to report.

Item 4. Other Business Activities

Mr. Boshnack is an Investment Advisor Representative with Vision Investment Advisors. As mentioned above Mr. Boshnack is the president and owner of Three Lakes Trading Company, Inc. and a managing member of JLC Futures Management Company LLC. He is also a principal of Luke Asset Management Partners LLC.

Three Lakes Trading Company is a Futures Brokerage and Managed Futures company. Mr. Boshnack receives compensation from Three Lakes Trading Company based on the sale of futures and commodity options transactions.

JLC Futures Management Company LLC is a Commodity Fund – CPO. Mr. Boshnack is a general partner and an owner of 1/3 of the company. Mr. Boshnack receives compensation from JLC Futures Management Company LLC based on incentive fees and commission rebates.

Luke Asset Management Partners LLC ("LAMP") is a registered Commodity Trading Advisor - CTA. Mr. Boshnack is a Principal of the firm and Three Lakes Trading Company (which he is the sole owner) is 50% owner of the company. Mr. Boshnack receives compensation from LAMP based on management and incentive fees and commission rebates for only his own clients that he introduces to LAMP.

Mr. Boshnack does not receive any commissions from clients of Vision Investment Advisors. As per the Form ADV, he receives a percentage of the fully-disclosed fees charged to the client under written agreement. Mr. Boshnack's relationship with Three Lakes Trading Company, Inc. and JLC Futures Management Company LLC does not create a material conflict of interest with clients. The compensation Mr. Boshnack receives for his work with Three Lakes Trading Company, Inc. and JLC Futures Management Company LLC significantly affects his income.

Item 5. Additional Compensation

Mr. Boshnack does not receive any additional compensation or economic benefits from providing advisory services.

Item 6. Supervision

Investment Advisor Representatives ("IARs") hold either a FINRA Series 7 and 66 or a Series 65 and are permitted to give advice to their clients and to discuss specific investments.
