### ***Disciplinary Information***

The SEC requires that all supervised persons listed on a firm's ADV Part 2 must disclose all material facts regarding any legal or disciplinary events material to a client's or prospective client's evaluation of the supervised person. No one at Excalibur Management Corporation, including Thomas S. Drumm, has ever been the subject of any criminal or civil court action, administrative proceeding by the SEC, or proceeding by a self-regulatory organization. Also, no one at Excalibur, including Mr. Drumm, has ever had any professional degree, designation, or license revoked or suspended.

### ***Other Business Activities***

The SEC requires all supervised persons listed on a firm's ADV Part 2 must disclose all material additional investment-related activities in which they are engaged. As previously disclosed, Thomas S. Drumm is a member of an Investment Advisory Committee of the John Hancock Mutual Life Insurance Company. The role of that Advisory Committee is limited to approving the Company's recommended methodology for determining the prices of non public securities in certain private transactions. However, for Mr. Drumm that activity does not provide a substantial source of income or involve a substantial amount of time.

### ***Additional Compensation***

The SEC requires that all supervised persons listed on a firm's ADV Part 2 must disclose any additional compensation they receive. As previously disclosed, Thomas S. Drumm is a member of an Investment Advisory Committee of the John Hancock Mutual Life Insurance Company and receives compensation for that service, which is not a substantial source of Mr. Drumm's total income.

### ***Supervision***
