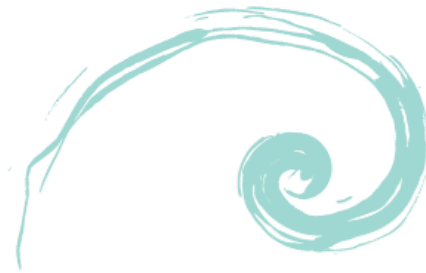

ITEM 2: EDUCATIONAL BACKGROUND AND BUSINESS EXPERIENCE

Amy Hubble is the Principal Investment Advisor Representative of Radix Financial, LLC (RADIX).
