Item 4- Advisory Business

A. Bergin & Co., LLC was formed in the Spring of 2009 as an Investment Advisor registered in the state of Pennsylvania. In January 2016, the firm subsequently changed its name to Ironview Capital Management, LLC (hereinafter "Ironview Capital Management, LLC" or "the firm") in 2011. The firm's principal owners are Ironview FLA LLC and Ironview Penn LLC. Ironview Capital Management, LLC was formed to provide financial and retirement planning advice along with investment management and investment advisory services. Ironview Capital Management, LLC provides these services to individuals, high net worth individuals, trusts, pension plans and group retirement plans.

B. With respect to institutional clients (Group Retirement Plan & Pension Plan Sponsors), Ironview Capital Management, LLC provides both asset allocation advice and models tailored to specific risk tolerance, financial situation and investment horizons, along with individual security selection. The latter may include the selection of open-end mutual funds and/or exchange traded funds (ETF's) in most cases. Ironview Capital Management, LLC serves as an ERISA 3(21) and ERISA 3(38) fiduciary in delivering investment advisory services to group retirement plans, predominantly 401k's.

Additional corporate consulting services are provided under limited circumstances surrounding operations, restructuring and growth strategies.

C. With respect to individual clients, Ironview Capital Management, LLC creates asset allocation models tailored to each individual client's risk tolerance, financial situation and investment horizon. With respect to the implementation of these tailored asset allocation models and security selection, the firm employs a combination of individual stocks, bonds, no-load mutual funds and exchange-traded funds (ETF's) and other securities. Ironview Capital Management, LLC does not limit its advice to any specific class of securities. Clients of the firm engage Ironview Capital Management, LLC to manage their entire portfolio and their overall asset allocation at times, and in certain instances the firm may only manage one area of their allocation (e.g., the portion of their portfolio they want to be invested in U.S. stocks). In addition to the aforementioned asset allocation strategies, Ironview Capital Management, LLC will at times and with select clients, employ listed stock options to protect principal, enhance yield or speculate on future price movements.

In regard to the no-load funds and ETF's in which we invest, we strive to use index funds wherever available and appropriate. We believe the low costs, low turnover, and better tax-efficiency inherent in index funds adds direct value to our clients' portfolios.

Clients may impose restrictions in investing in certain securities or types of securities in accordance with their values or beliefs. However, if the restrictions prevent IRONVIEW CAPITAL MANAGEMENT, LLC from properly servicing the client account, or if the restrictions would require IRONVIEW CAPITAL MANAGEMENT, LLC to deviate from its standard suite of services, IRONVIEW CAPITAL MANAGEMENT, LLC reserves the right to end the relationship.

D. A wrap fee program is an investment program where the investor pays one stated fee that includes management fees, transaction costs, fund expenses, and any other administrative fees. IRONVIEW CAPITAL MANAGEMENT, LLC does not participate in any wrap fee programs.

E. As of December 2018, Ironview Capital Management, LLC directly managed approximately \$914,034,695.00 in client assets, which includes approximately 329 client accounts. More specifically, the firm manages 304 accounts with total assets of \$889,034,695.00 on a discretionary basis and \$25,000,000.00 on a non-discretionary basis (25 non-discretionary client accounts).

Item 5- Fees & Compensation

A. Ironview Capital Management, LLC is compensated for services rendered in three ways: (1) a percentage of assets under management, (2) a monthly or quarterly retainer fee, or (3) via an hourly billing rate. The Ironview Capital Management, LLC percentage of assets under management fee schedule is as

follows: 1.00% per annum for assets under management of less than \$5,000,000, 0.85% per annum for assets under management between \$5,000,000 and \$10,000,000, and fees are negotiable for portfolios larger than \$10,000,000.

With respect to ERISA group retirement plans (e.g., 401k, 403b, etc.), the percentage of assets under management fee schedule is as follows: 0.75% on plans with total plan assets less than \$5,000,000, and fees are negotiable for plans with assets greater than \$5,000,000.

Ironview Capital Management, LLC 's hourly rate is \$350 per hour for either Financial Planning or Corporate Consulting and any retainer fee is typically based upon an estimate of time spent on the job at this hourly rate. The fixed retainer fee is charged in advance. A refund will be provided upon termination of services and a prorated amount will be returned to the client based upon the work completed to the date of termination. Fixed fees charged could range from \$350 to \$25,000. The above fee schedules are typical, but all fee arrangements are negotiable.

B. All client billing with respect to Ironview Capital Management, LLC private clients is billed quarterly in arrears and advance. (i.e., we bill 1/4th of our annual asset based fee for the 1st quarter of the calendar year in April. We bill 1/4th of our annual asset based fee for the 2nd quarter of the calendar year in July, etc.). With respect to group retirement plan advisory business, we may bill either monthly or quarterly, but in both cases the billing is in arrears and advance.

Fees may be paid via direct fee deduction. Prior to any fees being deducted from a Client's account Ironview Capital Management, LLC will obtain the written authorization from each Client. Ironview Capital Management, LLC will send the Custodian a notice as to the amount of the fee to be deducted.

C. In addition to the fees clients pay to Ironview Capital Management, LLC, clients are also subject to fees and expenses at both the fund (mutual fund or (ETF) exchange traded fund) level and custodian level. Additionally, the client's custodian may charge a per trade fee (when Ironview Capital Management, LLC both buys and sells a security for a client) of approximately \$10 (may be significantly more in some cases).

D. Ironview Capital Management, LLC collects fees in arrears and advance. Refunds for fees paid in advance, to departing clients will be payable within 30 days of their notification of the termination of the relationship in writing. Fees will be returned to the client via check, or return deposit back into the client's account.

For all asset based fees paid in advance, the fee refunded will be equal to the balance of the fees collected in advance minus the daily rate* times the number of days elapsed in the billing period up to and including the day of termination. (*The daily rate is calculated by dividing the annual asset-based fee by 365.)

For hourly fees that are collected in advance, the fee refunded will be the balance of the fees collected in advance minus the hourly rate times the number of hours of work that has been completed up to and including the day of termination.

E. Ironview Capital Management, LLC does not have any proprietary investment products (funds, ETF's, annuities, etc.) from which we derive additional revenue, nor does the firm receive commissions or any other form of compensation as a result of the sale of any securities in any way.

Item 6- Performance Based Fees and Side-by-Side Management

IRONVIEW CAPITAL MANAGEMENT, LLC does not receive any performance-based fees.

Item 7- Types of Clients

Ironview Capital Management, LLC provides advisory, financial planning and investment management services to the following types of clients:

- Individuals
- High Net Worth Individuals (net worth in excess of \$1,000,000)
- Trusts, Endowments/Foundations
- Group Retirement Plans (401k's, SIMPLE IRA's, SEP-IRA's, etc.)
- Corporate clients

At this time, Ironview Capital Management, LLC does not have a stated minimum fee or minimum account size required to work with the firm.

Item 8- Methods of Analysis, Investment Strategies and Risk of Loss

Ironview Capital Management, LLC employs a comprehensive approach to its wealth management process. While the amount of the firm's involvement with a client's assets and overall financial plan varies, the firm is always required to clearly discuss the client's goals and risk tolerances, along with the risks that any eventual allocation managed by the firm carries. Depending on the nature of the firm's engagement with a client, methods in the firm's wealth management process may include (but are not limited to):

- 1) Client Discovery - Consultation to learn the client's financial circumstances and risk tolerances, as well as determine the goals for the firm's engagement.
- 2) Allocation Process - After determining a client's goals and tolerances for the assets for which the firm is engaged, the firm may, where appropriate in managing a client's portfolio, seek to use modern portfolio theory as a guiding principle in its investment process. This process takes into account future projections for various asset class returns, as well as historical allocations between asset classes, in order to determine a theoretical optimal portfolio allocation for a client. Generally, the firm will seek to principally use passive index funds to serve as proxies for this allocation.
- 4) Individual Securities - Where the firm believes individual securities may benefit a client's portfolio, fundamental/valuation analysis or technical analysis may be employed in determining securities purchased and the timing of these purchases.
- 5) Use of Derivatives - Where appropriate, the firm may use options and other derivative instruments to hedge a client's portfolio or seek to alter return profiles of a client's portfolio. The use of these securities may increase or decrease the risk of a client's portfolio.
- 6) Low-Cost Investing - Given that cost is a primary factor in investment returns, generally speaking, the firm will seek to use the lowest cost share class of funds available to a client, and seek to mitigate client transaction costs through efficient purchase planning.

It is important to note that investing in all securities, including the securities and strategies discussed in this brochure, involve the risk of loss that clients/investors should prepare to bear. Each of the investments and strategies discussed will experience periods of loss, and the loss may be material. Specifically, equity (stock) investment strategies, and those employing them, should be prepared to have their money decrease by 50% or more in a single year with certain individual securities at times experiencing total loss.

Item 9- Disciplinary Information

On December 11, 2013, Benjamin Roberts entered into a Stipulation and Consent Agreement with the State of Florida, Office of Financial Regulation. The Stipulation and Consent Agreement and administrative fine of \$18,750 was the result of an inadvertent violation of state licensing requirements caused by a misplaced reliance on the State's de minimis business rule during a period of preparation for the firm moving from state to SEC registration. Item 10- Other Financial Industry Activities and Affiliations

A. No employee of Ironview Capital Management, LLC is a registered representative of a broker dealer or has pending applications with such.

B. Neither Ironview Capital Management, LLC nor its employees are registered or have pending registrations to become a Futures Commission Merchant, Commodity Pool Operator, or a Commodity Trading Adviser.

C. Benjamin Roberts, Rahuk Kothari are owners of Ironview FLA LLC.

Sean A. Bergin, Kevin Mullen, and Justin Delisi are owners of Ironview PENN LLC.

From time to time, they may offer clients advice or products from those activities and clients should be aware that these services may involve a conflict of interest. Ironview Capital Management, LLC always acts in the best interest of the client and clients always have the right to decide whether or not to utilize the services of any Ironview Capital Management, LLC representative in such individual's outside capacities.

Sean Bergin is a licensed insurance agent and owner of Hamilton Benefits, LLC an insurance agency.. From time to time, he and other registered insurance agents of Ironview Capital Management, LLC will offer clients advice or products from those activities. Clients should be aware that insurance services pay a commission and involve a conflict of interest, as commissionable products conflict with fiduciary duties of a registered investment adviser. Ironview Capital Management, LLC always acts in the best interest of the client; including the sale of commissionable insurance products to advisory clients. Clients are in no way required to implement the plan through any representative of Ironview Capital Management, LLC in such individual's outside capacities.

Sean A. Bergin is a director and greater than 10% owner of Hamilton Equity Partners, LP, a real estate partnership. This is a family business enterprise and will not be offered to other clients of Ironview Capital Management, LLC.

Bradley Jacob Rosen is a licensed insurance agent. From time to time, he will offer clients advice or products from this activity. Clients should be aware that these services pay a commission and involve a possible conflict of interest, as commissionable products can conflict with the fiduciary duties of a registered investment adviser. Ironview Capital Management LLC always acts in the best interest of the client; including in the sale of commissionable products to advisory clients. Clients are in no way required to implement the plan through any representative of Ironview Capital Management LLC in their capacity as a licensed insurance agent.

D. IRONVIEW CAPITAL MANAGEMENT, LLC does not utilize nor select other advisors or third-party managers. All assets are managed by IRONVIEW CAPITAL MANAGEMENT, LLC management.

Item 11- Code of Ethics, Participation or Interest in Client Transactions and Personal Trading

A. Ironview Capital Management, LLC has a written Code of Ethics that covers the following areas: Prohibited Purchases and Sales, Insider Trading, Personal Securities Transactions, Exempted Transactions, Prohibited Activities, Conflicts of Interest, Gifts and Entertainment, Confidentiality, Service

on a Board of Directors, Compliance Procedures, Compliance with Laws and Regulations, Procedures and Reporting, Certification of Compliance, Reporting Violations, Compliance Officer Duties, Training and Education, Record keeping, Annual Review, and Sanctions. Our Code of Ethics is available free upon request to any client or prospective client.

B. Ironview Capital Management, LLC does not recommend that clients buy or sell any security in which a related person to Ironview Capital Management, LLC or Ironview Capital Management, LLC has a material financial interest.

C. From time to time, representatives of Ironview Capital Management, LLC may buy or sell securities for themselves that they also recommend to clients. This may provide an opportunity for representatives of Ironview Capital Management, LLC to buy or sell the same securities before or after recommending the same securities to clients resulting in representatives profiting off the recommendations they provide to clients. Such transactions may create a conflict of interest. Ironview Capital Management, LLC will always document any transactions that could be construed as conflicts of interest and will always transact client business before their own when similar securities are being bought or sold.

D. From time to time, representatives of Ironview Capital Management, LLC may buy or sell securities for themselves at or around the same time as clients. This may provide an opportunity for representatives of Ironview Capital Management, LLC to buy or sell securities before or after recommending securities to clients resulting in representatives profiting off the recommendations they provide to clients. Such transactions may create a conflict of interest. Ironview Capital Management, LLC will always transact client's transactions before its own when similar securities are being bought or sold.

Item 12- Brokerage Practices

A. One custodian, Schwab Institutional, a division of Charles Schwab & Co., Inc., (CRD # 5393), was chosen based on their relatively low transaction fees and access to mutual funds and ETFs. Ironview Capital Management, LLC will never charge a premium or commission on transactions, beyond the actual cost imposed by the custodian.

Another custodian, FolioFn Institutional, was chosen to enable a limited number of clients to access a platform that favors high frequency trading. Ironview Capital Management, LLC will never charge a premium or commission on transactions, beyond the actual cost imposed by the custodian.

1. Ironview Capital Management, LLC receives what it considers as Soft Dollar Benefits from Schwab. These benefits are covered under the "Safe Harbor" of eligible soft dollar benefits provided by section 28(e) of the Securities Exchange Act of 1934. The services Ironview Capital Management, LLC receives are comprised of research. The research received may not benefit all clients. There is no incentive for Ironview Capital Management, LLC to direct clients to this particular broker-dealer over other broker-dealers who offer the same services; however, because this firm does not have to produce or pay for services or products it has an incentive to choose a custodian that provides those services based on its interests rather than the clients' interests.

2. Ironview Capital Management, LLC receives no referrals from a broker-dealer or third party in exchange for using that broker-dealer or third party.

3. Ironview Capital Management, LLC allows clients to direct brokerage: however, Ironview Capital Management, LLC may recommend custodians. Ironview Capital Management, LLC may be unable to achieve most favorable execution of client transactions if clients choose to direct brokerage. This may cost clients money because without the ability to direct brokerage Ironview Capital Management, LLC may not be able to aggregate orders to reduce transactions costs resulting in higher brokerage commissions and less favorable prices. Not all investment advisers allow their clients to direct brokerage.

B. Ironview Capital Management, LLC maintains the ability to block trade purchases across accounts. Block trading may benefit a large group of clients by providing Ironview Capital Management, LLC the ability

to purchase larger blocks resulting in smaller transaction costs to the client. Declining to block trade can cause more expensive trades for clients.

Item 13- Review of Accounts

Ironview Capital Management, LLC's Managing Partners, Sean A. Bergin and Benjamin C. Roberts, review client accounts on a quarterly basis, and financial plans on an annual basis. The firm may also, based on market conditions or changes in our clients' personal situations, review accounts or financial plans on a more frequent basis.

Item 14- Client Referrals and Other Compensation

A. Ironview Capital Management, LLC does not receive any economic benefit, directly or indirectly from any third party for advice rendered to Ironview Capital Management, LLC clients.

B. If an unaffiliated or an affiliated solicitor introduces a client to Ironview Capital Management (Ironview,) we may pay that solicitor a referral fee in accordance with the requirements of Rule 206(4)-3 of the Investment Advisers Act of 1940, and any corresponding state securities law requirements. If an unaffiliated solicitor introduces a client to Ironview, that solicitor will disclose the nature of the solicitor relationship with Ironview at the time of the solicitation. In addition, the solicitor will provide each prospective client with a copy of this brochure, and a copy of the written disclosure statement from the solicitor to the client disclosing the terms and conditions of the arrangement between Ironview and the solicitor, including the compensation that Ironview pays the solicitor and whether or not the client is paying higher fees to Ironview as a result of the solicitation. Any affiliated solicitor will disclose the nature of the relationship to Ironview at the time of the solicitation and will provide all prospective clients with a copy of this brochure.

Item 15- Custody

Ironview Capital Management, LLC, with client written authority, has limited custody of client's assets through direct fee deduction of Ironview Capital Management, LLC's fees only. If the client chooses to be billed directly by Schwab Institutional, a division of Charles Schwab & Co., Inc., (CRD # 5393), or FolioFm, then Ironview Capital Management, LLC must have written authorization from the client to do so. Clients will receive all account statements and billing invoices that are required, and they should carefully review those statements for accuracy.

Item 16- Investment Discretion

Ironview Capital Management, LLC is granted "discretion" in terms of placing trades in many client accounts. Clients executed a discretionary investment advisory agreement and/or a limited power of attorney clause in the contract between the client and the custodian detailing the roles, responsibilities and rights of both Ironview Capital Management, LLC and the client with respect to this type of advisory arrangement. Typically, Ironview Capital Management, LLC and the client reach a general agreement with respect to the client's long-term strategic asset allocation and the vehicles the firm will use in constructing this allocation policy. Under these arrangements, Ironview Capital Management, LLC is permitted to buy, sell, and rebalance the allocation based on our understanding of the client's long-term goals, financial situation and risk tolerance. Any material changes in the portfolio are also discussed with clients of the firm in a timely manner, but not necessarily before the adjustments (i.e., trades) are executed.

Item 17- Voting Client Securities

Ironview Capital Management, LLC does not elect to have authority to vote clients' securities. Proxy contests and other voting matters and the materials requesting input into such matters are sent directly to

our clients by either Schwab or FolioFn (custodians). That being said, clients do, in certain cases, seek the recommendation of Ironview Capital Management, LLC in this regard. In these cases, Ironview Capital Management, LLC performs a cursory analysis of the relevant proposal and provides an opinion on what we believe to be the action or vote which is in the best interest of the client. It is still the Client's responsibility to vote as they see fit. All opinions rendered to Client's will be kept on file by BR&Co.

Item 18- Financial Information

Ironview Capital Management, LLC does not require nor solicit prepayment of more than \$1200 in fees per client, six months or more in advance and therefore does not need to include a balance sheet with this brochure.

Neither Ironview Capital Management, LLC nor its management have any financial conditions that are likely to reasonably impair our ability to meet contractual commitments to clients.

Ironview Capital Management, LLC has not been the subject of a bankruptcy petition in the last ten years.
