Formal Education: Mr. Jacobus earned a Bachelor of Science degree in Mechanical Engineering from Northeastern University in Boston, Massachusetts in 1986. He completed post-graduate studies in corporate finance as well as in international portfolio management at the Instituto de Estudios Superiores de Administracion in Caracas, Venezuela, in 1994 and in 1998, respectively. Mr. Jacobus earned his Masters in Business Administration and International Finance from ESCP-EAP Ecole Europeenne des Affaires in Paris, France, in 2001.

Business Experience: Mr. Jacobus is the owner and President of Finser. Since 2002, Mr. Jacobus has been serving as a member of the Board of Directors of Venezuela's Catholic Priest Pension Fund. Since 2006, he has served as the Chief Financial Officer of Foninsa - Fondo Inmobiliario Santiago (Chile) and, since 2005, the Chief Financial Officer for Grupo Tepuy - Reserva la Dehesa (Chile). In 2012 Mr. Jacobus made an investment in Puroast Coffee, where he holds less than 2% of the company. From 1988 to 1992, he worked as an International Financial Analyst for Exxon Corporation in Caracas, Venezuela.

Item 4 – Other Business Activities

As set forth in Item 2 above, Mr. Jacobus serves as a member of the Board of Directors of Venezuela's Catholic Priest Pension Fund, as the Chief Financial Officer of Foninsa - Fondo Inmobiliario Santiago (Chile), as the Chief Financial Officer for Grupo Tepuy - Reserva la Dehesa (Chile). In 2018 Mr. Jacobus initiated a Real Estate Management business Kronus Management LLC. He also is the sole owner of FINSER Asset Management LLC a Florida S Corp used for Mr. Jacobus's proprietary trading activities. Mr. Jacobus owns 60% of KAVAK Investments 2018 LLC, a real estate investment enterprise dedicated to purchasing real estate. Mr. Jacobus devotes approximately 80 percent of his professional time to Finser and serving its clients. Mr. Jacobus does not receive commissions, bonuses or other cash or non-cash compensation based on the sale of securities or other investment products in the Finser advisory accounts. Mr. Jacobus is not actively engaged in any noninvestment-related business or occupation that represents a substantial source of his income or involves a substantial amount of his time.

Item 5 – Additional Compensation

Mr. Jacobus is the sole owner of Finser. As the sole shareholder, Mr. Jacobus may receive distributions and profits from Finser beyond a regular salary. Mr. Jacobus does not receive any compensation or additional economic benefits from any third party for providing advisory services through Finser. As

Managing Director of Kronus Management LLC, Mr. Jacobus is entitled to distribution should these be available.

Item 6 – Supervision
