## **Item 2 – Educational Background and Business Experience**

Ms. Jamison is the Managing Director of CHANGE Global Investment, LLC (“CHANGE Global”). As such, she is responsible for the managerial oversight and leadership of the firm. CHANGE Global is an asset management firm established in April 2013 to pursue investment opportunities in the developing economies of Africa, Asia, Eastern Europe, and Latin America.

Ms. Jamison has researched and invested in emerging markets on behalf of institutional investors and high net worth individuals for the past fifteen years. Her professional career started in 1997 when Donaldson, Lufkin & Jenrette, Inc. formed an Eastern European desk in London. Subsequently, Ms. Jamison worked as a global emerging markets analyst at Nicholas Applegate (1998-2002), and in a global portfolio management role at Morgan Stanley (2004-2008). Most recently (2008-2013), Ms. Jamison was the portfolio manager at Frontier Market Asset Management, focusing on investments in the global frontier emerging markets.

Ms. Jamison earned her Master of Business Administration degree from Stanford University and her Bachelor of Science in International Business, summa cum laude, from Menlo College. In 2003, Ms. Jamison was awarded the Chartered Financial Analyst (“CFA”) designation, also known as a CFA charter. The CFA charter is an investment credential intended to demonstrate knowledge needed for investment analysis and decision making. It is recognized by regulatory bodies in 19 countries as a proxy for meeting certain licensing requirements. To obtain and maintain the CFA designation, Ms. Jamison was required to have four years of qualifying investment work experience; to become a member of the CFA Institute, a global association of investment professionals that administers the CFA charter; to pledge to adhere to the CFA Institute Code of Ethics and Standards of Professional Conduct on an annual basis; to apply for membership in a local CFA membership society; to obtain a bachelor’s degree, and to complete the CFA Program - a graduate-level curriculum of investment analysis and portfolio management skills and knowledge.

Ms. Jamison is a member of the CFA Society of Portland.

Ms. Jamison was born in 1975.
