Liting Shao is a licensed insurance agent. Liting Shao is the Finance Director at Nikkiso's Clean Energy & Industrial Gases Group, specializing in cryogenic solutions for clean energy and industrial gas markets. She oversees financial strategies for advanced technologies in LNG, hydrogen liquefaction, and CO2 capture. She dedicates 4 hours monthly during trading hours and 7 hours monthly outside trading hours to this business, with 53% of compensation tied to performance.

Liting Shao, a CFO consultant at Eden Consulting, works remotely, providing fractional CFO services. She dedicates 0.08 hours/month during trading hours and 0.33 hours/month outside, expecting 4% of yearly compensation from the business.
