Formal Education: Mr. Simon graduated as a CPA with a major in business administration from the Universidad de la República located in Montevideo, Uruguay.

Business Experience: Mr. Simon is an Investment Adviser Representative of Intercam Advisors. In addition, he serves as a Registered Representative of Intercam Securities, both in Miami FL

Mr. Simon began his financial career in 1981 at the First National Bank of Boston as a credit analyst where over a period of 10 years occupied various positions ending as CFO. From 1991 to 1993, he served at Pepsi Cola bottling company in Uruguay as CFO. Starting in 1994, Mr. Simon was the CEO of Banco de Montevideo. In 1999 he joined ABN AMRO bank, in Montevideo, serving as Commercial Manager and later as Country Executive running all operations, including CEO of the bank and President of Real Seguros an affiliated company of ABN AMRO Bank operating as an insurance company. In 2005 he was transferred to Miami, FL as Senior Vice President where he ran ABN AMRO's Latin American Private Banking operations until December 2006.

In 2014 Mr. Simon founded as a minority partner, with other German individual investors, Proreta Tactical GmbH in Germany. The company is dedicated to build training centers, shooting ranges, refurbish existing shooting ranges and provide ballistic and non-ballistic walls for realistic close quarter battle training to police special forces units mainly located in Germany, Austria, Luxembourg, and Switzerland. The company owns and operates two training centers in the vicinity of Frankfurt, Germany.

He joined Intercam Advisors in March of 2023 and Intercam Securities in January 2023.

Mr. Simon also holds an insurance license in Florida (0215 Life Incl Var Annuity & Health) where he is an agent of American Family Life Assurance Company of Columbus – AFLAC. He does not devote any time to this business and has received/receives no compensation.
