## **Item 2 – Educational Background and Business Experience**

*Name of Supervised Person:* Everardo Vidaurri

*Year of Birth:* 1963

*Formal Education:* Mr. Vidaurri earned his M.B.A. from European University in Belgium and his B.A. in business administration from Universidad Panamericana in Mexico City.

*Business Experience:* Mr. Vidaurri is a Director and the Chief Executive Officer of Intercam Advisors and member of Intercam Advisor's Investment Committee. He also serves as the Chief Executive Officer of Intercam Securities, Inc. and Intercam Futures, Inc., affiliates of Intercam Advisors and Managing Director of Intercam Banco Internacional. Before joining Intercam Advisors, from June of 2006 to September of 2009, Mr. Vidaurri was the Chief Executive Officer and Chief Compliance Officer of Progress Investments, LLC. He was also the Chief Executive Officer and Chief Compliance Officer of Progress Advisors, LLC. From December of 2000 to April of 2006, Mr. Vidaurri was associated with BNP Paribas Investment Services LLC, which provided international private banking services to high-net-worth individuals domiciled primarily in Latin America. He served as the Chief Executive Officer of BNP Paribas. From 1996 to 2000, he was the President of Inverlat International, a broker/dealer based in New York. From 1993 to 1996, Mr. Vidaurri worked for Serfin Securities in New York. Prior to that, he worked for approximately eight years with major Mexican broker/dealers, and primarily dealt with foreign institutional clients investing in Mexican securities.

## **Item 3 – Disciplinary Information**

## **Item 4 – Other Business Activities**

As set forth in Item 2 above, Mr. Vidaurri serves as the Chief Executive Officer of Intercam Securities, Inc. and Intercam Futures, Inc. Mr. Vidaurri devotes approximately 20 percent of his professional time to Intercam Advisors and serving its clients. Mr. Vidaurri may receive commissions, bonuses or other cash or non-cash compensation from Intercam Securities based on the sale of securities or other investment products in the advisory accounts. He, also, maintains a Life Including Variable Annuity and Health Insurance License in the State of Florida and Texas. Mr. Vidaurri effective June 2022, is the manager of PC FLY LLC, a Delaware LLC (a non-investment related business) affiliated with Intercam's group that holds an aircraft lease. He dedicates one hour monthly. Mr. Vidaurri effective August 2022, is the managing Director of Intercam Banco Internacional, Inc. – Puerto Rico. He dedicates fifteen hours monthly.

## **Item 5 – Additional Compensation**

Mr. Vidaurri may receive bonuses that are based, in part, on the number or amount of sales, client referrals, or new accounts. As described above, Mr. Vidaurri might also receive compensation from Intercam Securities. Mr. Vidaurri does not receive any compensation or additional economic benefits from any other third party for providing advisory services through Intercam Advisors.

## **Item 6 – Supervision**

Mr. Vidaurri serves as the Chief Executive Officer of the Firm. There is no person at the Firm senior to Mr. Vidaurri. Mr. Vidaurri's telephone number is (305) 377-8008. Ultimately, Mr. Vidaurri is responsible for supervision of the individuals providing investment advice to clients. Given the small number of clients and employees at the Firm, supervision is performed on an individual client basis.
