Jennifer spends approximately 95% of her professional time in her sales capacities at REI.

Jennifer is also a licensed insurance agent. Jennifer may recommend insurance products to advisory clients. She is paid a commission for selling such products. She spends approximately 5% of her time in her capacity as an insurance agent.
