Sean Spencer has a financial industry affiliated business as an independent insurance agent. Not more than 20% of his time is spent on these activities. From time to time, he offers clients advice or products from those activities. He may receive separate yet typical compensation in the form of commissions for the sale of insurance products.

These practices represent a conflict of interest because they give Mr. Spencer an incentive to recommend products based on the commission amount received. This conflict is mitigated by the fact that Mr. Spencer has a fiduciary responsibility to place the best interest of the client first and the clients are not required to purchase any products. Clients have the option to purchase these products through another insurance agent of their choosing.

Mr. Spencer is also involved in the non-investment-related businesses JM of Wichita, LLC, a franchisee for Jersey Mike sub shops, The Croft, LLC, created for the purpose of developing/purchasing real estate, and C&S Holdings, LLC, a holding company for purpose of investing. He also serves as a board member on the Wichita State University Dean's Advisory Board for the W. Frank Barton School of Business. Not more than 3% of his time is spent on these activities.
