

### Introduction

Our firm, TRG Investment Advisors, LLC dba TRG Retirement Plan Consultants, is an investment adviser registered with the Securities and Exchange Commission. We feel that it is important for you to understand how advisory and brokerage services and fees differ in order to determine which type of account is right for you. There are free and simple tools available to research firms and financial professionals at [www.investor.gov/CRS](http://www.investor.gov/CRS), which also provides educational materials about investment advisers, broker-dealers, and investing.

### What investment services and advice can you provide me?

We are a registered investment adviser that offers investment advisory services, including Asset Management, Wrap Comprehensive Portfolio Management and 529 Account Management, to clients. If you open an advisory account with our firm, we'll meet with you to understand your current financial situation, existing resources, objectives, and risk tolerance. Based on what we learn, we'll recommend a portfolio of investments that is monitored at least annually, and if necessary, rebalance to meet your changing needs and goals. We'll offer you advice on a regular basis and contact you at least annually to discuss your portfolio.

You have the choice to receive non-discretionary or discretionary services from us, that is, whether we are allowed to buy and sell investments in your account without asking you in advance ("discretion") or only after receiving your permission ("non-discretion"). If you select non-discretion, you make the ultimate decision regarding the purchase or sale of investments. Any limitations will be described in the signed advisory agreement. We will have discretion or non-discretion until the advisory agreement is terminated by you or our firm.

We offer a wide variety of investment products and types of investments, and we do not restrict our advice to limited types of products or investments. For retail clients, our firm requires a minimum household account balance of \$300,000 to open and maintain an account for our Wrap Comprehensive Portfolio Management services, but does not otherwise impose requirements for opening and maintaining accounts or engaging us. Financial Planning & Consulting is included in our Wrap Comprehensive Portfolio Management services for no additional fee.

### What fees will I pay?

You will be charged an ongoing annual fee applied quarterly based on the value of the assets in your account. Our Comprehensive Portfolio Management maximum annual fee is 1.25%. The fee for 529 Account Management services will not exceed 0.6%. The more assets you have in your advisory account, the more you will pay us. We therefore have an incentive to increase the assets in your advisory account in order to increase our fees. Our fees vary and are negotiable. The amount you pay will depend, for example, on the services you receive and the amount of assets in your account. Our firm's fees will be automatically deducted from your advisory account, which will reduce the value of your advisory account. Our firm does not offer direct invoicing. It is important to note that Asset Management services are only available to friends and family and are not assessed an advisory fee.

The custodian that holds your assets charges you a maintenance fee to custody your account(s). The custodian's maintenance fees are in addition to our firm's fees for our 529 Account Management services.

We pay the custodian's transaction fees charged to you for our Wrap Comprehensive Portfolio Management services. The fees for some wrap fee programs can be higher than a typical asset-based advisory fee. Clients who subscribe to our Asset Management services pay for the transaction fees incurred in their account(s).

You may also pay charges imposed by the custodian holding your accounts for certain investments and maintaining your account. Some investments, such as mutual funds, index funds, exchange traded funds, and variable annuities, charge additional fees that will reduce the value of your investments over time. In addition, you may have to pay fees such as “surrender charges” to sell certain illiquid securities.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

- Help me understand how these fees and costs may affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs and how much will be invested for me?

**What are your legal obligations to me when acting as my investment adviser?  
How else does your firm make money and what conflicts of interest do you have?**

*When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:*

Our firm’s financial professionals include licensed insurance agents who sell insurance products for a commission. They have an incentive to recommend insurance products to you in order to increase their compensation.

For our wrap services, we pay the custodian’s transaction fees charged to you except for U.S. listed equities and exchange traded funds, which do not have transaction fees. As a result, we have an incentive to recommend these asset types without transaction fees in order to reduce the amount of the custodian’s transaction fees that we will have to pay on your behalf.

**How do your financial professionals make money?**

Our financial professionals are compensated based on the revenue our firm earns from their advisory services or recommendations, the amount of client assets they service, and the time and complexity required to meet a client’s needs. In addition, they are compensated based on the type of insurance product sold and/or product sales commissions.
