Titan Managers, LLC dba Titan Capital Management is registered with the Securities and Exchange Commission as an investment advisor. Brokerage and investment advisory services and fees differ and it is important to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisors, and investing.

What investment services and advice can you provide me?

We provide investment management and basic financial planning services to clients. We continuously monitor the holdings in our models. We work with multiple asset classes including: global stocks, global bonds, commodities and currencies. We primarily use exchange traded funds and individual stocks in our strategies. Trades are executed in the account when our models generate buy or sell signals. Financial plan reviews and updates are provided when requested by the client. Our general initial investment minimum is \$500,000, however this may be waived.

Our investment advisory services are offered on a discretionary basis which means we don't need to call you when buying or selling in your account. You give us this authority when you sign our investment management agreement. This agreement will remain in place until you or we terminate it.

What fees will I pay?

You will be charged an ongoing annual fee, billed in quarterly installments. This fee is based on your account value as of the last day of each calendar quarter. Our standard fee schedule follows.

<u>Assets under Management</u>	<u>Annual Fee</u>
On the first \$2,000,000	1.00%
On the next \$3,000,000	0.75%
On amounts over \$5 million	Negotiable

Minimum annual fee: \$3,000

Fees are not negotiable for accounts below \$5 million. Basic financial planning services are included in the above fees. Note that there is a conflict of interest with the implementation of the financial plan; we receive increased fees if you include us in the implementation of the financial plan. The more assets you have in your advisory account, the more you will pay us. This gives us an incentive to encourage you to increase the assets in your account which will increase our fees.

The broker/dealer (custodian) that holds your assets can charge you a transaction fee when we buy or sell an investment for you. The custodian's transaction fees are in addition to our fee for advisory services. You may also pay charges imposed by the custodian holding your account for certain investments and maintaining your account. Some investments, such as mutual funds, index funds, exchange traded funds, and variable annuities charge additional fees that will reduce the value of your investments over time.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. What are your legal obligations to me when acting as my investment advisor? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

We recommend Charles Schwab & Co., Inc. to serve as custodian to our clients. These custodians provide us with certain products and services at no cost that benefit us but do not benefit our clients. Certain of these products and services assist us in managing and administering our clients' accounts and others help us develop our business. The receipt of these products and services creates a conflict of interest because it gives us an incentive to have clients choose one of these custodians as a custodian. You may choose a different custodian for us to use.

How do your financial professionals make money?

Financial professionals receive a salary to avoid conflict of interest. One of our financial professionals is also an owner of the firm. His compensations includes net income from the business, in addition to his salary. As such, he has an incentive to increase the assets in your account which will increase the compensation he receives.
