Investment Authority. We manage investment accounts on a discretionary basis. Discretionary investment management means that the Advisor makes the ultimate decision to invest in a specific investment.

Investment Offerings. We provide advice on various types of investments. Our services are not limited to a specific type of investment and/or product.

Account Minimums and Other Requirements. In general, we do not require a minimum household dollar amount to open and maintain advisory accounts.

At this time, Veridian Private Wealth Management has chosen to work with the following custodian: Charles Schwab. Veridian Private Wealth Management Capital Management's advisory fees are separate from the fees charged by Charles Schwab. Veridian Private Wealth Management Capital Management's annual advisory fee schedule(s) and details are as follows:

Veridian Private Wealth Management Capital Management's advisory fees, are negotiated, will not exceed 1.0% of Assets Under Management (AUM), and are based on complexity and guided by the total market value of the assets under advisory. Veridian Private Wealth Management does not charge additional fees over and above our agreed to advisory fee. ETFs and Mutual funds have internal fees and expenses, in which Veridian Private Wealth Management does not receive or share in these fees. Veridian Private Wealth Management clients may incur brokerage and other transaction costs by the custodian. Veridian Private Wealth Management does not receive these fees nor do we share in these fees; see ADV 2A Item 12 for additional information. - ***What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?***

Standard of Conduct:

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. An example of a conflict is Veridian Private Wealth Management receives additional compensation when a client adds money to increase the accounts value.

- ***How might your conflicts of interests affect me, and how will you address them?***

How do your financial professionals make money?

Veridian Private Wealth Management investment advisory representatives are compensated based on the amount of client assets (i.e. Cash & Securities) under management in which they service.
