

Introduction

GeoCapital LLC (“Geo”) is an investment adviser registered with the Securities and Exchange Commission and provides advisory services rather than brokerage services. Investment advisory and brokerage services and fees differ, and it is important for retail investors to understand the differences. This document gives you a summary of the types of services we provide and how we are compensated. Please feel free to ask us for more information - some suggested questions are provided as examples. What investment services and advice can you provide me?

Geo offers separately managed accounts (“SMAs”) to retail investors and various organizations. Advisory services are developed in consultation with you and managed on a discretionary basis subject to an investment management agreement (“IMA”). Investments strategies are typically built around small capitalization stocks and guided by each client's stated objectives (i.e., maximum capital appreciation, growth, income, or growth and income), as well as tax considerations. Accounts are continuously monitored as part of this service. New accounts are typically subject to a \$250,000 minimum asset value at inception, although we may reduce or waive that minimum, at our discretion, based upon various criteria including our historical relationship, the type of assets, and any related accounts.

- Given my financial situation, should I choose an investment advisory service? Why or why not?
- How will you choose investments to recommend to me?
- What is your relevant experience, including your licenses, education and other qualifications? What do those qualifications mean?

What fees will I pay?

Clients typically pay for advisory services via an ongoing, asset-based fee, subject to the IMA you execute with us. Fees for SMAs may be up to 1.5% annually of assets under management depending on the complexity and level of service provided, your total assets under management, or other circumstances we deem relevant. Asset-based fees subject Geo to a potential conflict of interest in that the more assets there are in your advisory account, the more you will pay in fees, and thus the firm has an incentive to encourage you to increase the assets in the account. Fees are generally deducted from your account quarterly, typically in arrears, subject to the terms of your IMA. In certain circumstances, fees and other terms may be subject to negotiation.

Geo's investment management fees do not include other expenses incurred in connection with our advisory services, such as custodial fees, brokerage commissions and other transaction costs. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

Questions to Ask Us:

- Help me understand how these fees and costs may affect my investments. If I give you \$250,000 to invest, how much will go to fees and costs and how much will be invested for me?
- How might your conflicts of interest affect me, and how will you address them?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we must act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

Asset-based fees subject us to a potential conflict of interest in that the more assets there are in your advisory account, the more you will pay us in fees, and thus we have an incentive to encourage you to increase the assets in the account. Similarly, we have an incentive to recommend ongoing services versus hourly or fixed fees.

Our employees are paid a salary by Geo and may earn bonuses based on overall firm revenue. Additionally, Geo's principals are entitled to income from the revenue the firm earns.

Do you or your financial professionals have legal or disciplinary history?
