

Yosemite Capital Management, LLC (“we,” “our,” or “us”) is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services and fees differ, and it is important for you to understand these differences. #### What investment services and advice can you provide me?

We offer investment advisory services to retail investors such as you through the management of your separate account. As part of our standard services, we monitor each account on an ongoing basis, using our current model portfolios as a guide, and we typically furnish clients with portfolio performance reports on a semi-annual basis. Our authority to manage a retail investor’s account is usually discretionary, which means that you authorize us to select the identity and amount of securities to be bought or sold, subject to your chosen strategy and stated investment objectives. On occasion, we agree to manage accounts on a non-discretionary basis, which means that we must obtain the client’s consent prior to transacting in any portfolio trades. For most retail investors, we primarily invest client assets in exchange-traded funds (“ETFs”) and mutual funds. Depending on the individual needs of the client, we sometimes also invest in stocks, bonds, treasuries, variable annuities, foreign securities, real estate investment trusts (“REITs”) and/or private funds. Our minimum account size is \$250,000 and we generally combine family accounts to meet the minimum. Limitations on investments typically include limitations by plan sponsors, mutual fund selections of no-load or waived load funds, and any client-imposed limitations. Additionally, investment management services are sometimes provided through independent, third-party investment advisers. We also offer financial planning services, which focus primarily on retirement planning, retirement plan allocations and investments, as well as CFO services to provide wealth enhancement, wealth transfer and wealth protection, and charitable giving options to achieve the client’s objectives.

Depending on the sophistication, risk tolerances, and qualifications of the client, from time to time we recommend that a portion of such a client’s assets be invested in certain affiliated and unaffiliated private investments. APHD I, LLC, a company owned by Mr. Paul Heckler, Managing Director of YCM, is a minority member of INTRUST Investment Management, LLC, the Manager of the IIM Harrison Partners, LLC Fund and IPG Monica Partners, LLC Fund, which are unaffiliated private real estate funds. #### What fees will I pay?

We charge an annual fee of 2% for balanced/equity portfolios and 1% for fixed income portfolios. Fees based on the total assets in your account and are payable quarterly in advance. Fees charged by the unaffiliated third-party managers we sometimes utilize vary depending upon the manager selected, the size of the account, and the services provided. The fees charged by outside managers are separate and in addition to our management fees. The more assets there are in your account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account. Our fee does not include (and you will pay separately) any applicable charges imposed by custodians, brokers and other third parties such as brokerage commissions,

transaction fees, custodial fees, wire transfer and electronic fund fees, and other fees and taxes on your account and on the securities transactions in your account. Money market funds, mutual funds, and ETFs also charge their own internal management fees. Fees for financial planning services are separate from our investment advisory service fees and payable on a fixed or monthly basis based on a rate of \$400 per hour.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

**When we act as your investment adviser**, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you.
