**Item 1. Introduction**

- A. **Gunder Wealth Management, LLC is registered with the Securities and Exchange Commission as an investment advisor and we provide investment advisory services rather than brokerage services.** Investment advisory services, brokerage services, and fees differ and it is important for the retail investor to understand the differences. This document gives you a summary of the types of services we provide and how you pay. Please ask us for more information.

**Item 2. Relationships and Services**

***What investment services and advice can you provide me?***

**Description of Services:** We provide Investment Management Services, Financial Planning, and Employee Benefit Plan Services to retail investors.

**Monitoring:** As a part of our standard services, we monitor your investment account on an annual basis or when an event triggers a review.

**Investment Authority:** We buy and sell investments in your account without asking you in advance, this is called “**discretionary authority**”. We may give you advice and you decide what investments to buy and sell, this is called “**non-discretionary authority**”. We offer both discretionary and non-discretionary authority accounts.

**Limited Investment Offerings:** Our investment advice is not limited to a particular type of security. We provide advice on stocks, bonds, certificates of deposit, municipal securities, mutual funds and options in securities.

**Account Minimums and other requirements:** We do not have an account minimum, however we have a minimum investment management fee of \$7,500.

**Additional Information:** Our firm initially filed for registration with the Securities and Exchange Commission (SEC) on 11/12/2024. The Co-owners of the firm are Ashlee DeSteiger (Chief Compliance Officer/CCO) and Joseph DeSteiger. We provide financial planning and portfolio management services to individuals, high net-worth individuals and pension and profit sharing plans.

**Item 3. Fees, Costs, Conflicts, and Standard of Conduct**

***What fees will I pay?***

**Description of Principal Fees and Costs:** Our on-going **asset-based fee** rang from 0.50% to 1.00%, and is paid in advance on a quarterly basis for our services, based on the value of the cash and investments in your advisory account. Our **hourly fee** for financial planning is \$400 per hour paid in advance. Our ongoing financial planning **fixed fee** ranges from \$5,500 to \$6,300 annually. When investment management services are used, comprehensive financial planning is included in the investment advisory fee. Our one-time financial plan fixed fee ranges from \$5,000 to \$9,000 based on complexity. Half of the fee is due upfront, and the remainder is due upon delivery of the plan, or in monthly installments over an agreed upon time period. Our employee benefit plan services fee ranges from 0.40% - 0.70%, and is paid on a quarterly basis.

**Description of Other Fees and Costs:** You are responsible for all custodial and securities broker-dealer execution fees charged by the custodian and executing broker-dealer. Our asset-based fee is separate and distinct from the custodian and broker-dealer execution fees. Some investments (such as mutual funds) impose additional fees that will reduce the value of your investment over time.

**Additional Information:** You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. Refer to our Form ADV Part 2A Brochure, Item 5.A.B.C.D. for more detailed information about our fees.

#### **Standard of Conduct**

*When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.*

**Examples of Ways We Make Money and Conflicts of Interest:** The more assets there are in your advisory account, the more you will pay in fees, and the firm may therefore have an incentive to encourage you to increase the assets in your account.

We are paid by the asset-based fee that is charged to your investment account. The more assets you have in your advisory account, including cash, the more you will pay us. We therefore have an incentive to increase the assets in your account in order to increase our fees. We are also compensated by ongoing, hourly, one-time, and flat fees.
