

On August 25, 2009, I issued an Order Making Findings and Revoking Registrations by Default in this administrative proceeding. One of the seven defaulting Respondents was Hemdale Communications, Inc. (Hemdale).

On September 29, 2009, I received the attached letter from Eric Parkinson, CEO of Hannover House USA, concerning the Hemdale default order. The letter states that a group of Hemdale shareholders is exploring the possibility of reinstating Hemdale's corporate charter with the State of Delaware and then filing all of Hemdale's overdue periodic reports with the Securities and Exchange Commission (Commission).

I do not consider Mr. Parkinson's letter as a motion to set aside the default as to Hemdale. See Rule 155(b) of the Commission's Rules of Practice. Accordingly, I plan to take no further action on the letter.

The original letter has been provided to the Office of the Secretary for inclusion in the official docket. A copy of the letter has been provided to Neil J. Welch, Jr., counsel for the Division of Enforcement.

Dear Judge Kelly:

As per our telephone conversation last week, I have been contacted by a substantial number of former shareholders in Hemdale who have inquired about the viability or opportunity to resurrect the company into good standing and to begin operations anew. Hemdale Communications, Inc. has been essentially inactive since 1995, following a bankruptcy filing and liquidation.

Last October, the founder and chairman of the company, film producer John Daly, passed away. John Daly and David Hemmings (*both now deceased*), formed "Hemdale" in 1967, and built it into one of the more prominent and successful independent movie studios in the 1980's. The company won the Best Picture Oscar for both "Platoon" and "The Last Emperor", and produced over 100 other films including "Terminator", "Hoosiers", and "Kiss of the Spiderwoman." In respect of the legacy of the company and to honor its founders, a group of former shareholders and I are exploring the means to re-launch the company brand.

We are taking steps to restore the corporation's good standing with Delaware, and have solicited our outside auditors (*Hogan Taylor/Tulius Taylor & Sartin*) to prepare a bid for the filing all of the past years of reporting requirements. If both endeavors are met with reasonable resistance and expense, then we will be contacting you regarding your recent Administrative Proceeding (No. 3-13545) with a motion to make a motion to set aside the default under Rule 155 and to take steps to reinstate Hemdale's status with the S.E.C.
