The hearing as to John B. Kern is set to commence on January 27, 2014, in New York City. He requests an extension of time, to which the Division of Enforcement does not object, until January 3, 2014, to file motions concerning requests for relief that he included in his Answer to the Order Instituting Proceedings. His deadline, originally October 15, 2013, has been extended several times. See, e.g., Craig Berkman d/b/a Ventures Trust LLC, Admin. Proc. Rulings Release No. 1050 (A.L.J. Nov. 18, 2013), 2013 SEC Lexis 3642. It will be extended again as requested. However, any further extension would be inconsistent with 17 C.F.R. §§ 201.161, .360. Additionally, although ordered to agree on a proposed prehearing procedural schedule, the parties have not done so. Accordingly, the deadline for the parties' exchange of witness and exhibit lists, expert reports, and prehearing briefs will be January 17, 2014.
