ORDER CONSOLIDATING PROCEEDINGS AND DESIGNATING PRESIDING JUDGE

The Securities and Exchange Commission (Commission) has ordered, pursuant to Rule 360(a)(2) of the Commission's Rules of Practice, that the Administrative Law Judge assigned to these proceedings shall issue initial decisions no later than 120 days from service of the Orders Fixing Time and Place of Public Hearing and Instituting Proceedings. See 17 C.F.R. § 201.360(a)(2).

The Commission has also ORDERED that the hearing in these matters commence at 9:30 a.m., Tuesday, February 18, 2014, in the Commission Headquarters Offices, Hearing Room 2, 100 F Street, N.E., Washington, D.C. 20549.

On February 3, 2014, the Division of Enforcement filed a Motion to Consolidate, stating, inter alia, that the allegations against Respondent La Paz Mining Corp. are nearly identical to the allegations made against the other nineteen Respondents named in Administrative Proceeding File Nos. 3-15716 through 3-15734. Rule 201 of the Commission's Rules of Practice allows an administrative law judge to consolidate proceedings involving a common issue of law or fact. 17 C.F.R. § 201.201. The rule is discretionary and is applicable where it appears appropriate to avoid unnecessary cost or delay. These administrative proceedings involve common questions of law and share similar fact patterns. Consolidation will permit a more efficient use of judicial resources and avoid unnecessary costs. Accordingly, the Motion to Consolidate is GRANTED, and IT IS ORDERED that Administrative Proceeding File Nos. 3-15716 through 3-15734, are hereby consolidated with Administrative Proceeding File No. 3-15715.

IT IS FURTHER ORDERED that Chief Administrative Law Judge Brenda P. Murray preside at the hearing in this consolidated proceeding and perform other and related duties in accordance with the Commission's Rules of Practice.

Service of all orders and rulings on parties is made by the Office of the Secretary, or other duly authorized Commission officer, pursuant to Commission Rule of Practice 141. See 17 C.F.R. § 201.141.
