The Securities and Exchange Commission (Commission) instituted this proceeding with an Order Instituting Proceedings (OIP), pursuant to Section 12(j) of the Securities Exchange Act of 1934 (Exchange Act), on May 21, 2014. Only Perfectenergy International Limited (Respondent) remains in the proceeding. The OIP alleges that Respondent is a corporation with a class of securities registered with the Commission pursuant to Section 12(g) of the Exchange Act and has repeatedly failed to file required periodic reports. The Division of Enforcement is seeking to revoke the registration of Respondent's securities.

Respondent has not yet been served with the OIP. To allow time for service and for Respondent's Answer,² the prehearing conference scheduled for October 24, 2014, will be postponed and will be held by telephone on January 23, 2015, at 10:00 a.m. EST, if the proceeding has not been resolved by then.
