ORDER POSTPONING
HEARING AND SCHEDULING
PREHEARING CONFERENCE

The Securities and Exchange Commission (Commission) commenced this proceeding on October 22, 2014, with an Order Instituting Administrative Proceedings (OIP) pursuant to Section 12(j) of the Securities Exchange Act of 1934 (Exchange Act). The OIP alleges that Respondents each have a class of securities registered with the Commission pursuant to Exchange Act Section 12(g) and are delinquent in their periodic filings, in violation of Exchange Act Section 13(a) and Rules 13a-1 and/or 13a-13. A hearing is scheduled to commence on November 17, 2014.

On October 29, 2014, the Division of Enforcement (Division) filed the Declaration of Neil J. Welch, Jr. to Assist Secretary with Record of Service, representing that Respondents 21st Century Telesis II, Inc., Agemark Corp., Alnilam Corp., American Centrality Group, Inc., and China Feicui Guodian Group Ltd. had been served with the OIP by October 25, 2014.¹

I find that 21st Century Telesis, Agemark, American Centrality, and China Feicui were served with the OIP by October 25, 2014, in accordance with Commission Rule of Practice 141(a)(2)(ii). 17 C.F.R. § 201.141(a)(2)(ii). The Declaration states that the Secretary mailed the OIP to Alnilam at the address shown on its most recent EDGAR filing of 3151 Airway Ave., Suite P-3, San Jose, CA 95123. The address shown on Alnilam's most recent filing, a Form 10-

QSB for the quarter ended June 30, 2008, is 3151 Airway Ave., Suite P-3, Costa Mesa, CA 92626. I find that Alnilam was not served in accordance with Rule 141(a)(2)(ii). *Id.*

To allow time for service on Alnilam and any answer, the November 17, 2014, hearing is POSTPONED *sine die*, and a prehearing conference is ORDERED for December 22, 2014, at 10:30 a.m. EST.
