## ORDER FOLLOWING THIRD PREHEARING CONFERENCE

For Review of Actions Taken by Self-Regulatory Organizations

On May 16, 2014, the Securities and Exchange Commission (Commission) issued an Order Establishing Procedures and Referring Applications for Review to Administrative Law Judge for Additional Proceedings. *Sec. Indus. & Fin. Mkts. Ass'n*, Securities Exchange Act of 1934 Release No. 72182, 2014 SEC LEXIS 1686. I held prehearing conferences on June 23 and December 18, 2014. A hearing is scheduled to begin on April 20, 2015. *Sec. Indus. & Fin. Mkts. Ass'n*, Admin. Proc. Rulings Release No. 2042, 2014 SEC LEXIS 4435 (Nov. 19, 2014). I held a third prehearing conference on December 30, 2014, in an effort to resolve a dispute about two subpoenas the Securities Industry and Financial Markets Association (SIFMA) requested that I issue to NASDAQ Stock Market LLC (NASDAQ) and NYSE Arca, Inc. (NYSE Arca) (collectively the Exchanges). Prior to the third prehearing conference, the parties made a number of filings including SIFMA's Amended Request for Issuance of Subpoenas Pursuant to Rule 232 of the Commission's Rules of Practice, filed December 22, 2014, and NYSE Arca and NASDAQ's oppositions, filed separately on December 29, 2014.<sup>1</sup> The Exchanges submitted a letter stating their position on the subpoenas on December 18, 2014.

At the prehearing conference on December 30, 2014, the parties could not agree on any aspects of SIFMA's original or amended subpoena requests. I agreed to correct my ruling as to subpoena request number three, and ruled that I would issue modified subpoenas as soon as possible.
