The Securities and Exchange Commission (Commission) instituted this proceeding with an Order Instituting Proceedings (OIP), pursuant to Section 12(j) of the Securities Exchange Act of 1934 (Exchange Act), on August 19, 2014. Only Flying Eagle PU Technical Corp. (f/k/a Sooner Holdings, Inc.) (Respondent) remains in the proceeding.¹ The OIP alleges that Respondent is a corporation with a class of securities registered with the Commission pursuant to Section 12(g) of the Exchange Act and has repeatedly failed to file required periodic reports. The Division of Enforcement is seeking to revoke the registration of Respondent's securities.

It appears that Respondent has not yet been served with the OIP. To allow time for service of the OIP on Respondent and for its Answer, the telephonic prehearing conference scheduled for April 10, 2015, will be postponed and will be held on August 7, 2015, at 10:00 a.m. EDT, if the proceeding has not been resolved by then.²

² The OIP provides that Respondent's Answer is due within ten days of service of the OIP on it. *See* OIP at 3; 17 C.F.R. § 201.220(b). If Respondent fails to file an Answer within the time provided, it will be deemed to be in default, and an order revoking the registration of its securities will be entered. *See* OIP at 3; 17 C.F.R. §§ 201.155(a), .220(f).
