ORDER FOLLOWING  
PREHEARING CONFERENCE

On June 17, 2015, the Securities and Exchange Commission issued an Order Instituting Proceedings under Section 12(j) of the Securities Exchange Act of 1934, alleging that Respondents have securities registered with the Commission and are delinquent in their periodic filings. Respondents were served by June 20, 2015, and their Answers were due by July 6, 2015. *Oraco Resources Inc.*, Admin. Proc. Rulings Release No. 2873, 2015 SEC LEXIS 2652 (June 26, 2015). Respondent Wolverine Holding Corp. (a/k/a Mobility Plus Medical Equipment, Inc.) (Mobility) filed an Answer on June 25, 2015; and Respondent Soltera Mining Corp. filed an Answer on June 29, 2015. On July 2, 2015, the Commission issued a consent order that revoked the registration of Respondent Smoky Market Foods, Inc.'s securities, ending the proceeding as to Smoky Market Foods. *Oraco Resources Inc.*, Exchange Act Release No. 75352, 2015 WL 4061338 (July 2, 2015).

A telephonic prehearing conference was held on July 7, 2015, attended by the Division of Enforcement and representatives of Respondent SaviCorp (a/k/a Savi Media Group, Inc.), Soltera, and Mobility. The Division represented that a signed offer of settlement as to Respondent Oraco Resources, Inc., has been submitted to the Commission and that the Division expects a consent order to issue shortly as to Oraco. The Division and a representative of SaviCorp represented that SaviCorp has signed an offer of settlement, the offer will be submitted to the Commission shortly, and a consent order as to SaviCorp likely will issue shortly.

As discussed at the prehearing conference, the following prehearing schedule is ordered as to Soltera and Mobility:

July 28, 2015: Motions for summary disposition are due;

August 18, 2015: Oppositions are due; and

September 4, 2015: Replies, if any, are due.
