POSTPONEMENT ORDER

The Securities and Exchange Commission instituted this proceeding with an Order Instituting Proceedings (OIP), pursuant to Section 12(j) of the Securities Exchange Act of 1934, on December 30, 2015. The OIP alleges that Respondent is a corporation with a class of securities registered with the Commission pursuant to Section 12(g) of the Exchange Act and has repeatedly failed to file required periodic reports. The Division of Enforcement (Division) is seeking to revoke the registration of Respondent's securities.

Respondent, a defaulted Nevada corporation located in China, has not yet been served with the OIP. The Division is attempting to serve Respondent in China pursuant to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents in Civil or Commercial Matters, at "the most recent address shown on [its] most recent filing with the Commission," in accordance with 17 C.F.R. § 201.141(a)(2)(ii), (iv). To allow time for service of the OIP and an Answer, the telephonic prehearing conference scheduled for January 27, 2017, will be postponed to July 28, 2017, at 10:00 a.m. EDT, if the proceeding has not been resolved by then.

If Respondent fails to file an Answer within the time provided, it will be deemed to be in default, and the undersigned will enter an order revoking the registration of its securities. *See* OIP at 2-3; 17 C.F.R. §§ 201.155(a)(2), .220(f).
