The Securities and Exchange Commission instituted this proceeding with an Order Instituting Proceedings (OIP), pursuant to Section 12(j) of the Securities Exchange Act of 1934, on September 22, 2017, and the hearing was scheduled to commence on October 25, 2017. The OIP alleges that each Respondent is a corporation with a class of securities registered with the Commission pursuant to Section 12(g) of the Exchange Act and has repeatedly failed to file required periodic reports. The

Division of Enforcement is seeking to revoke the registration of Respondents' securities.

The OIP provides that each Respondent's Answer is due within ten days of service of the OIP on it. *See* OIP at 3; 17 C.F.R. § 201.220(b). Each Respondent was served with the OIP, in accordance with 17 C.F.R. § 201.141(a)(2)(ii), by September 29, 2017. Power of the Dream Ventures, Inc., has filed an Answer. None of the remaining Respondents has filed an Answer.

Accordingly, each remaining Respondent – IMK Group, Inc., Mobile Bits Holding Corporation and National Energy Services, Inc. – is ORDERED TO SHOW CAUSE, by October 26, 2017, why it should not be deemed to be in default and the registration of its securities revoked. *See* OIP at 3; 17 C.F.R. §§ 201.155(a)(2), .220(f).

IT IS FURTHER ORDERED that the hearing is POSTPONED *sine die*, and that the Division and Power of the Dream Ventures, Inc., submit by October 26, 2017, a proposal for further steps to resolve the proceeding as to that Respondent. The proposal may include specific dates for the parties to file motions for summary disposition pursuant to 17 C.F.R. § 201.250(b), oppositions, and replies.
