Scheduling Order

On October 16, 2017, the Division of Enforcement and Respondent Gold Hill Resources, Inc., submitted a joint prehearing conference statement. Gold Hill has already filed an answer to the order instituting proceedings. And the parties agree that the Division has made the investigative file available to Gold Hill for inspection and copying pursuant to Commission Rule of Practice 230, 17 C.F.R. § 201.230. Accordingly, I set the following procedural schedule, based on the parties' proposed schedule, as modified below:

November 9, 2017: Completion of production of any documents not already

produced, as set forth in Rules of Practice 230 and 232, 17 C.F.R. §§ 201.230, .232. Parties are responsible for requesting and serving their own subpoenas. Subpoena forms are available online at http://www.sec.gov/alj.

November 13, 2017: Motions for summary disposition under Rule of

Practice 250(b), 17 C.F.R. § 201.250(b), are due.

December 11, 2017: Oppositions to summary disposition are due.

December 18, 2017: Replies in support of summary disposition are due.

Expert witness reports under Rule of Practice 222(b),

17 C.F.R. § 201.222(b), if any, are due.

January 5, 2018: Subpoenas under Rule 232 requiring the attendance of

witnesses at the hearing are due.

January 26, 2018:

Optional, ten-page prehearing briefs are due. Briefs that merely duplicate summary disposition briefing are unhelpful and unnecessary.

Witness and exhibit lists are due. The parties should also exchange, but not file, copies of marked exhibits.

Written stipulations, including stipulations concerning the contents, authenticity, or admissibility of documents, are due. The parties have already stipulated to the authenticity of "documents filed on EDGAR concerning Gold Hill" and have agreed that official notice under Rule of Practice 323, 17 C.F.R. § 201.323, may be taken of "any filings and/or lack of filings on EDGAR by Gold Hill and its officers and directors."

February 1, 2018:

Final telephonic prehearing conference at 1:00 p.m. Eastern.

February 5, 2018:

The hearing, if necessary, will be set for one day and will begin at a time and location to be determined. After the close of the parties' evidentiary presentation, I will establish a post-hearing schedule for the filing of briefs and exhibits.
