Order Finding Service, Directing Respondents to Show Cause, and Scheduling Prehearing Conference

On September 22, 2017, the Securities and Exchange Commission issued an order instituting proceedings (OIP) against Respondents under Section 12(j) of the Securities Exchange Act of 1934. After a prior initial decision was vacated by the Commission, the proceeding was reassigned to me on September 12, 2018. *Pending Admin. Proc.*, Admin. Proc. Rulings Release No. 5955, 2018 SEC LEXIS 2264, at \*2–3 (ALJ). The parties were provided the opportunity to propose how further proceedings should be conducted. *IMK Grp.*, Admin. Proc. Rulings Release No. 6029, 2018 SEC LEXIS 2455 (ALJ Sept. 19, 2018). No Respondent filed a proposal. On October 9, 2018, the Division of Enforcement reported that it was unable to contact any of the remaining Respondents.

Based on the Division's declarations regarding service dated October 4, 2017, and accompanying exhibits, I find that Respondents were each served with the OIP. IMK Group, Inc., a void Delaware corporation, was served on

September 29, 2017, by delivering the OIP to the Delaware Secretary of State. 17 C.F.R. § 201.141(a)(2)(i), (ii); 8 Del. Code ann. § 321(b). MobileBits Holdings Corporation and National Energy Services, Inc., were served by September 27, 2017, by U.S. Postal Service Priority Mail Express attempted delivery at the address listed on each company's most recent filing with the Commission. 17 C.F.R. § 201.141(a)(2)(ii). Respondents' answers were due by October 10, 2017. OIP at 3; 17 C.F.R. §§ 201.160(a)–(b), .220(b). To date, no remaining Respondent has filed an answer.

I ORDER IMK Group, MobileBits Holdings, and National Energy Services to SHOW CAUSE by November 2, 2018, why the registration of their securities should not be revoked by default due to their failures to file answers, submit proposals for the conduct of further proceedings, or otherwise defend this proceeding. If a Respondent fails to respond to this order or otherwise defend the proceeding, it will be deemed in default and the registrations of its securities will be revoked. OIP at 3; 17 C.F.R. §§ 201.155(a)(2), .220(f).

I FURTHER ORDER that a telephonic prehearing conference will be held on December 4, 2018, at 10:00 a.m. EST, if this matter has not been concluded before then.
