**Order Finding Service and
Setting Answer Deadline
for Solo International, Inc.**

On May 23, 2018, the Securities and Exchange Commission issued an order instituting proceedings (OIP) against Respondents under Section 12(j) of the Securities Exchange Act of 1934.¹ The proceeding was reassigned to me on September 12, 2018. *Pending Admin. Proc.*, Admin. Proc. Rulings Release No. 5955, 2018 SEC LEXIS 2264, at *2, *4 (ALJ). The parties were provided the opportunity to propose how further proceedings should be conducted. *Solo Int'l, Inc.*, Admin. Proc. Rulings Release No. 6087, 2018 SEC LEXIS 2599, at *1-2 (ALJ Sept. 26, 2018). But neither remaining Respondent filed a proposal. In an October 30, 2018, filing, the Division of Enforcement represents that it was unable to contact either of them.

On June 8 and 25, 2018, the Division submitted declarations of service. After independently reviewing the declarations, I find that they establish that Your Event, Inc., and Solo International, Inc., were served with the OIP on May 26, 2018, and June 20, 2018, respectively, by U.S. Postal Service Priority Mail Express to the most recent address shown on each Respondent's most recent filing with the Commission. 17 C.F.R. § 201.141(a)(2)(ii). Your Event's answer was due by June 8, 2018. OIP at 3; 17 C.F.R. §§ 201.160(b), .220(b). To date, it has not filed an answer.

¹ Urban Hydroponics, Inc., settled with the Commission and is no longer part of this proceeding. *Solo Int'l, Inc.*, Exchange Act Release No. 83420, 2018 SEC LEXIS 1380 (June 12, 2018).

Solo International's answer would have been due by July 3, 2018, if not for the Commission's stay of all pending administrative proceedings on June 21, 2018. *Pending Admin. Proc.*, Securities Act of 1933 Release No. 10510, 2018 SEC LEXIS 1490; *see* OIP at 3; 17 C.F.R. §§ 201.160(b), .220(b). When the Commission allowed the stay to expire on August 22, 2018, it vacated all pending deadlines. *Pending Admin. Proc.*, Securities Act Release No. 10536, 2018 SEC LEXIS 2058, at *2-3.

Because Solo International has not proposed how further proceedings should be conducted, I exercise my authority under the Commission's August 22 order to ORDER Solo International to file its answer by November 13, 2018. *See id.* at *3-4.
