**Order Finding Service and  
Directing Gamzio Mobile, Inc.,  
to Show Cause**

On September 11, 2017, the Securities and Exchange Commission issued an order instituting proceedings (OIP) against Respondents under Section 12(j) of the Securities Exchange Act of 1934.<sup>1</sup> On September 19, 2017, the Division of Enforcement submitted a declaration of service. After independently reviewing the declaration, I find that the declaration establishes that Gamzio Mobile was served with the OIP on September 13, 2017, by U.S. Postal Service Priority Mail Express to the most recent address shown on Respondent's most recent filing with the Commission. 17 C.F.R. § 201.141(a)(2)(ii). Its answer was due by September 26, 2017. OIP at 3; 17 C.F.R. §§ 201.160(b), .220(b). To date, it has not filed an answer.

After a prior initial decision was vacated by the Commission, the proceeding was reassigned to me on September 12, 2018. *Pending Admin. Proc.*, Admin. Proc. Rulings Release No. 5955, 2018 SEC LEXIS 2264, at \*2, \*4 (ALJ). The parties were provided the opportunity to propose by October 15, 2018, how further proceedings should be conducted. *Gamzio Mobile, Inc.*, Admin. Proc. Rulings Release No. 6079, 2018 SEC LEXIS 2586, at \*2 (ALJ Sept. 25, 2018). Gamzio Mobile, Inc., did not file a proposal, and in an October 12, 2018, filing, the Division of Enforcement represented that it was unable to contact Gamzio Mobile.

I ORDER Gamzio Mobile to SHOW CAUSE by November 15, 2018, why the registration of its securities should not be revoked by default due to its failure to file an answer or otherwise defend this proceeding. If Gamzio Mobile fails to respond to this order, it shall be deemed in default, the proceeding will be determined against it, and the registration of its securities will be revoked. OIP at 3; 17 C.F.R. §§ 201.155(a)(2), .220(f); *Pending Admin. Proc.*, Securities Act of 1933 Release No. 10536, 2018 SEC LEXIS 2058, at \*4 (Aug. 22, 2018).
