THE REGISTRATION STATEMENT OF : ORDER

ELECTROPREMIUM :

The Securities and Exchange Commission instituted this proceeding with an Order Instituting Proceedings (OIP) on September 6, 2022, which was served on Respondent Electropremium by personal service on September 7, 2022, and was emailed to Respondent on September 6, 2002. The proceeding is a stop order proceeding, authorized pursuant to Section 8(d) of the Securities Act of 1933, concerning a Form S-1 Registration Statement filed by Electropremium. The OIP ordered Electropremium to file an Answer within ten days after service of the OIP and ordered that a hearing commence at 10:00 a.m. EDT on September 21, 2022, via remote means and/or at the Commission's offices at 100 F Street, N.E., Washington, DC 20549, "to determine whether the allegations of the Division of Enforcement are true; to afford the Respondent with an opportunity to establish any defenses to these allegations; and to determine whether a stop order should issue suspending the effectiveness of the Registration Statement." OIP at 2-3.

On September 12, 2022, the undersigned ordered that the hearing would be held remotely, via WebEx, starting at 10:00 a.m. EDT, as the Commission ordered, noting that instructions for joining the WebEx meeting had been sent to Respondent at its email address, Khurramafzal889@gmail.com and that any questions could be addressed to the Office of Administrative Law Judges (OALJ) at ALJ@sec.gov or 202-551-6030. The Registration Statement of Electropremium, Admin. Proc. Rulings Release No. 6868, 2022 SEC LEXIS 2338.

Respondent did not file an Answer, due on Monday, September 19, 2022. The hearing was held as scheduled, on September 21, 2022. Respondent did not appear. At the hearing, four exhibits were admitted and testimony was taken from Mary Beth Breslin, Chief of the Office of Real Estate & Construction, of the Commission's Division of Corporation Finance (CorpFin), and from Ricky Tong, a Division of Enforcement (Division) data analyst. Ms. Breslin described the processes of CorpFin with regard to Forms S-1 and her communications with Respondent. Mr. Tong described a telephone conversation between Respondent and a Division attorney that he monitored. A post-hearing briefing schedule was set: the due dates for the Division's opening filing, Respondent's opposition, and the Division's reply are October 12, October 26, and November 2, 2022, respectively.

After the hearing concluded, Respondent sent an email to OALJ, indicating a continued interest in the matter. If Respondent wishes to continue to participate in this proceeding, it should file an Answer to the OIP by September 28, 2022, and respond to the Division's post-hearing filing by the date ordered – October 26.
