ORDER AND AMENDED JUDGMENT

On June 9, 2004, the Court entered final judgment [74] in favor of the Securities and Exchange Commission against Richard Parnell and One Touch Marketing, Inc. In paragraph 6 of that order the Court inadvertently failed to include the dollar value of the civil penalty to be imposed on defendants Richard Parnell and One Touch Marketing, Inc. The Court now corrects that oversight.

In accordance with the final judgment entered by this Court on June 9, 2004, it is hereby ORDERED that the Final Judgment be amended to provide that defendants Richard Parnell and One Touch Marketing, Inc., jointly and severally, shall pay a civil penalty of \$804,051.00 pursuant to Section 20(d) (2) of the Securities Act, 15 U.S. § 77t(d)(2), and Section 21(d)(3) of the Exchange Act, 15 U.S.C. § 78u(d)(3). Defendants shall make this payment within ten (10) business days after entry of this Final Judgment by certified check, bank cashier's check, or United States postal money order payable to the Securities and Exchange Commission. The payment shall be delivered or mailed to the Office of Financial Management, Securities and Exchange

Commission, Operations Center, 6432 General Green Way, Mail Stop 0-3, Alexandria, Virginia 22312, and shall be accompanied by a letter identifying Richard B. Parnell and One Touch Marketing, Inc. as defendants in this action; setting forth the title and civil action number of this action and the name of this Court; and specifying that payment is made pursuant to this Order. Defendants shall simultaneously transmit photocopies of such payment and letter to the Commission's counsel in this action.
