## Updates

On December 16, 2024, EDGAR Release 24.4 will introduce the following changes:

- FEPT will be updated to address the following software defects:
  - Submission type “N-2” will be added to the list of forms in the “Carry Forward Form Type” field when the Security Type selected is “Unallocated (Universal) Shelf.”
  - FEPT will generate a warning message if filers attempt to claim offsets at the time of initial registration when relying solely on Rule 457(u) for submission form types F-3D and S-3D.
  
- For reference, Appendix A is included in this guide and provides the list of the 72 fee bearing submission types and their corresponding form and filing types.

## 1. PREPARING AN INLINE XBRL FILING FEE EXHIBIT

This chapter describes the general process for preparing an Inline XBRL filing fee exhibit (EX-FILING FEES) and submitting the exhibit to EDGAR for processing. Filers have the option to construct structured filing fee information within EDGAR using the Fee Exhibit Preparation Tool (FEPT). FEPT includes features such as prompts, explanations, and automated calculations to produce a filing fee exhibit in submission-ready format. Filers using FEPT to construct the EX-FILING FEES in EDGAR generally will receive error and warning messages before they submit both Test and Live filings. Filers that construct this structured information outside of FEPT, however, will receive error and warning messages after they submit both Test and Live filings. EDGAR will validate the Inline XBRL fee data submission and generally will issue warnings for any validation failures caused by incorrect or incomplete structured filing fee-related information until an announced date of approximately November 1, 2025, when it will suspend filings rather than issue warnings.

Important dates:

- January 29, 2024—Filers permitted to voluntarily file fee data in Inline XBRL format/voluntary compliance period for submission of structured fee exhibits starts (approximately six months prior to July 31, 2024)
- July 31, 2024—Large Accelerated Filers required to submit fee data in Inline XBRL format
- July 31, 2025—Compliance by all filers required, including certain investment companies that file registrations on Forms N-2 and N-14.

### 1.1 Key Features of FEPT

FEPT allows filers to enter filing fee-related disclosures into a web-based graphical user interface to generate an Inline XBRL-tagged filing fee exhibit based on user input. Filers may add, edit, and delete offering, offset, and combined prospectus fee data using FEPT. FEPT validates user input and helps filers correct any filing fee calculation errors prior to filing the submission.

Filers may assemble, validate, and generate the EX-FILING FEES exhibit using FEPT. When assembling fee data, filers may validate and correct any filing fee calculation errors prior to filing the submission. Filers will see warnings that are generated for each Inline XBRL exhibit. Filers may also view an in-progress or fully completed filing fees exhibit in a browser window. FEPT enables filers to save and restore fee exhibit data and also download their assembled fee exhibits. For more information on FEPT menu buttons (Save, Restore, Preview, etc.) refer to the Sections below.

FEPT has three tables:

- Table 1: Newly Registered and Carry Forward Securities OR
  - Table 1: Transaction Valuation for Exchange Act Forms and Schedule
- Table 2: Fee Offset Sources and Claims
- Table 3: Combined Prospectuses

Table 1 is generally a required table, with some exceptions, whereas Tables 2 and 3 are optional. Please see succeeding sections for details.

## 1.2 Accessing FEPT

FEPT is located on the EDGARLink Online interface at the “Documents” tab. To access the “Fee Exhibit Preparation Tool” hyperlink:

1. Log into the EDGAR Filing Website using your CIK and Password.
2. Select the “EDGARLink Online Form Submission” link under “Information Exchange” on the left side of your screen.
3. From the “EDGARLink Online Submission Type Selection” page, select a fee bearing submission, for example S-1, from the “Submission Type” box. The EDGARLink Online Main page for S-1 displays.
4. Enter the CIK and CCC on the EDGARLink Online Main Page. Complete all the required fields for the S-1 submission on the Main page.

**Note:** Rapidly using “tab” or otherwise quickly scrolling through the fields without allowing time for the system to finish processing data that has been entered on the screen may result in a 404 error and loss of data. To avoid this issue, please wait for the “Working...” message to complete and disappear before selecting a new data field.

5. Navigate to the “Documents” tab and select the “Attach Inline XBRL Filing Fee exhibit?” check box.

**Note:** For information on how to enable the “Fee Exhibit Preparation Tool” hyperlink based on the submission type, refer to Section 1.3 **Pre-requisites for Enabling the Fee Exhibit Preparation Hyperlink.**

The “Fee Exhibit Preparation Tool” hyperlink and the “Payor Info” tab are displayed on the EDGARLink Online interface replacing the fee header tabs “Fee Offsets” and “Offerings & Fees.”

6. Select “Yes” as a response to the warning message that displays: “Please choose YES only if you would like to attach the fee exhibit in a structured format (Inline XBRL) to the submission or access the Fee Exhibit Preparation Tool to generate and attach the filing fees exhibit. The Fee Exhibit Preparation Tool includes information for fee calculation in a structured format. The Inline XBRL exhibit attachment will be automatically attached to your EDGARLink Online submission. If this is not intended, please choose NO.”
7. Enter the Payor CIK and Payor CCC, if applicable, on the “Payor Info” tab.

8. Select the “Fee Exhibit Preparation Tool” hyperlink to access FEPT. FEPT opens and displays the Terms of Use. Refer to Section 1.4 for information on the FEPT Terms of Use.

### **1.3 Pre-Requisites for Enabling the “Fee Exhibit Preparation Tool” Hyperlink**

For initial registration statements, such as S-1, F-1, and S-3, Schedules, and their amendments, filers must enter a valid CIK and CCC on the EDGARLink Online Main tab to enable the “Fee Exhibit Preparation Tool” hyperlink on the “Documents” tab.

Filers must enter a valid CIK, CCC, and File Number on the EDGARLink Online “Main” tab to enable the “Fee Exhibit Preparation Tool” hyperlink for the following submission types:

- Amendments to the initial registration statements
- Prospectuses filed pursuant to Rule 424(b)

For MEF filings, filers must enter a valid CIK, CCC, and 462B File Number to enable the “Fee Exhibit Preparation Tool” hyperlink. The MEF filings are F-3MEF, N-2MEF, S-3MEF, SF-1MEF, SF-3MEF, F-1MEF, F-4MEF, S-4MEF, N-14MEF, S-1MEF, and S-11MEF.

For initial filings, FEPT displays the pre-populated Filer CIK, Submission Type, Form Type, and Name of Filer.

For amendments to initial registration statements, FEPT displays the Filer CIK, File Number, Submission Type, Form Type, and Name of Filer.

For MEF filings, FEPT displays Filer CIK, 462B File Number, Submission Type, Form Type, and Name of Filer.

### **1.4 FEPT Terms of Use**

Prior to using FEPT, filers must read and accept the following:

**Terms of Use:** The Fee Exhibit Preparation Tool (FEPT) is intended only as an aid to help filers calculate, disclose, and construct structured filing fee-related information and produce a filing fee exhibit in a format acceptable for submission as an EDGAR attachment (i.e., EX-FILING FEES). Filers that choose to use the FEPT remain fully responsible for properly calculating and paying all required fees and accurately representing all required information in their Commission filings. The Commission assumes no responsibility for and disclaims all liability associated with the filer’s use of the FEPT and information provided by the FEPT. The FEPT is not a rule, regulation, requirement, or statement of the Commission.

Use of the FEPT is optional. A filer can instead choose to construct its structured filing fee-related information outside of EDGAR in accordance with the requirements of the EDGAR Filer Manual and applicable technical specifications.

By checking the following box, filer acknowledges and accepts these terms as a condition to using the FEPT.

To acknowledge/accept the Terms of Use, filers must:

1. Select the checkbox at the bottom of the “Fee Exhibit Preparation Tool Terms of Use” dialog box.
2. On selecting the checkbox, the [Close] button is enabled.
3. Select the [Close] button to view FEPT. FEPT displays the pre-populated Filer CIK, Submission Type, Form or Filing Type, Name of Filer, and File Number as applicable. Note: For the list of submission types and their corresponding form types displayed on FEPT, refer to Appendix A, Section 2.1 “Submission Type to Form or Filing Type Mapping.”

Filers using FEPT are responsible for its output, and the use of the tool is optional. Filers may choose to construct their structured filing fee-related information outside of EDGAR in accordance with the requirements of the EDGAR Filer Manual, Filing Fee Disclosure (FFD) Taxonomy, and the EDGARLink Online Technical Specifications.

### **1.5 Adding Offering Line(s) to Table 1: Newly Registered and Carry Forward Securities**

Filers submitting a structured EX-FILING FEES exhibit in Inline XBRL format may use FEPT to add offering data in reliance on one of the following rules:

Offering Rule 457(a)	Offering Rule 457(o)
Offering Rule 457(r)	Offering Rule 457(s)
Offering Rule 457(u)	Offering Rule Other
Offering Rule 457(f) <sup>1</sup>	Carry Forward Rule 415(a)(6)

Filers may provide carry forward data by referencing Rule 415(a)(6) in “Table 1: Newly Registered and Carry Forward Securities.”

To add an offering line to “Table 1: Newly Registered and Carry Forward Securities” on FEPT:

1. Navigate to FEPT by following the steps described in Section 1.2.
2. Select the + icon to add an offering line under “Table 1: Newly Registered and Carry Forward Securities.”
3. Select “Rule 457(a)” from the “Fee Calculation or Carry Forward Rule” drop down list.

4. Select either “Fees To Be Paid” or “Fees Previously Paid,” to enter information for the relevant part of Table 1.
5. For securities not previously submitted on a prior registration, select “Fees To Be Paid.” On initial registration statements, the “Fees To Be Paid” option is selected by default.
6. For securities already included on a prior filing for the registration, select the “Fees Previously Paid.”
7. Select the type of securities to be offered using this registration statement from the “Security Type” drop down list. The options displayed are based on the Fee Calculation Rule selected, as applicable.
8. Enter a title of the class of securities to be offered using this registration statement in the “Security Class Title” field.
9. Enter the number of shares initially being registered in the “Amount Registered” field, if applicable for the rule selected.
10. Enter the price per share in the “Proposed Maximum Offering Price per Unit” field, if applicable for the rule selected.
11. FEPT automatically calculates the Maximum Aggregate Offering Price for each class of securities as the product of the “Amount Registered” and the “Proposed Maximum Offering Price Per Unit”, unless the filer explicitly enters a different amount as is sometimes appropriate e.g., where the filer selects Rule 457(o) and, as permitted, omits the “Amount Registered” and the “Proposed Maximum Offering Price Per Unit.”
12. FEPT automatically calculates the “Amount of Registration Fee” by multiplying the “Maximum Aggregate Offering Price” by the current “Fee Rate.”  
 Note: For previously paid line(s), the Amount of Registration Fee might not equal Aggregate \* Fee Rate if the previously paid shares were registered across multiple fiscal years or if other fee variables in the “Previously Paid” lines have been updated subsequent to the initial fee payment. As a result, you may override the automatically calculated “Amount of Registration Fee” for the previously paid line.

13. Enter a fee note (optional) of up to 10,000 characters to disclose specific details relating to the fee calculation to clarify the information presented for a particular offering line in Table 1.
14. Select “Save”. “Table 1: Newly Registered and Carry Forward Securities” displays the newly added offering line. Repeat steps 2 to 11 to add additional offering lines in Table 1.

1. Navigate to FEPT by following the steps described in Section 1.2.
2. Select the + icon to add an offering line under “Table 1: Newly Registered and Carry Forward Securities.”
3. Select “Rule 457(o)” from the “Fee Calculation or Carry Forward Rule” drop down list.
4. Move the slider to the “Yes” position as a response to the “Unallocated (Universal) Shelf” field. The FEPT automatically selects “Unallocated (Universal) Shelf” as the Security Type.
5. To include sub-items for “Unallocated (Universal) Shelf”:
  - a. Select an option from the “Security Type” drop down list.
  - b. Enter the “Security Class Title.”

Note: Because the Maximum Aggregate Offering Price field is optional for the sub-items, this field can be left blank.



- c. Select the + icon to add classes of securities. Repeat steps a. and b. depending on how many classes you want to include.
6. Enter the “Maximum Aggregate Offering Price” for the sub-items on a combined basis on the “Unallocated (Universal) Shelf” offering line. The FEPT automatically calculates the “Amount of Registration Fees” by multiplying the “Maximum Aggregate Offering Price” by the current “Fee Rate.” FEPT will not allow filers to include the “Security Class Title” field for the “Unallocated (Universal) Shelf” offering line.
7. Enter a fee note (optional) to disclose specific details relating to the fee calculation as necessary to clarify the information presented for a particular offering line in Table 1.
8. Click the [Save] button. The Fees To Be Paid “Unallocated (Universal) Shelf” offering line with the sub-items is displayed in “Table 1: Newly Registered and Carry Forward Securities.”

Note: On submission types F-10, F-10/A, and F-10EF, filers may choose to include a single “Unallocated (Universal) Shelf” offering line without including any sub-items and provide the Maximum Aggregate Offering Price on a combined basis in the “Unallocated (Universal) Shelf” offering line. FEPT will trigger the following warning message if filers do not include any sub-items in addition to the “Unallocated (Universal) Shelf” line, but filers can ignore the warning and proceed with generating the Inline XBRL fee exhibit.

“You have included an Unallocated (Universal) Shelf offering line with no sub-items. There should be at least one additional line with both a Security Type other than Unallocated (Universal) Shelf and a Security Class Title.”

Filers will be required to provide the Maximum Aggregate Offering Price when selecting “Unallocated (Universal) Shelf.” Alternatively, filers may optionally include sub-items in addition to the “Unallocated (Universal) Shelf” offering line. Filers may specify the Maximum Aggregate Offering Price for each sub-item on FEPT. If filers add sub-items to “Unallocated (Universal) Shelf,” FEPT will require filers to enter “Security Class Title” in addition to the “Security Type” for each sub-item included. Filers may carry forward securities on an “unallocated basis” in reliance on Rule 415(a)(6) on submission form types F-3, F-3/A, F-3MEF, F-3ASR, F-4, F-4/A, F-4MEF, N-2, N-2/A, N-2ASR, N-2 POSASR, N-2MEF, POS AM, POSASR, S-3, S-3/A, S-3ASR, S-3MEF, S-4, S-4/A, and S-4MEF. Filers must include the Unallocated (Universal) Shelf line and sub-items/child items for the parent Unallocated (Universal) Shelf line when relying on 415(a)(6).

**Note:** The option to carry forward a security type of “Unallocated (Universal) Shelf” on a POS AM filing will be available only when the underlying previously effective registration statement is eligible to register securities on an “unallocated basis” in reliance on Rule 415(a)(6).

1. Navigate to FEPT by following the steps described in Section 1.2.
2. Select the + icon to add a carry forward line under “Table 1: Newly Registered and Carry Forward Securities.”
3. Select “Rule 415(a)(6)” from the “Fee Calculation or Carry Forward Rule” drop down list.
4. Move the slider to the “Yes” position as a response to the “Unallocated (Universal) Shelf” field. The FEPT automatically selects “Unallocated (Universal) Shelf” as the Security Type.
5. To include the carry forward sub-items for “Unallocated (Universal) Shelf”:
  - a. Select an option from the “Security Type” drop down list.
  - b. Enter the “Security Class Title” of the sub-item to be carried forward.  
Note: FEPT will display a warning message if you attempt to carry forward any new security class/type combination not included on the original registration.
  - c. Select the form type of the earlier registration statement from which the sub-item is to be carried forward. The form types that you can select are F-3, F-4, N-2, S-3, and S-4.
  - d. Enter the file number of the earlier registration statement from which the sub-item is to be carried forward.
  - e. Enter the Initial effective date of the earlier registration statement for the sub-item being carried forward.  
FEPT will display field-level error messages if a response is missing for the following fields: Security Type, Security Class Title, Carry Forward Form Type, Carry Forward File Number, and Carry Forward Initial Effective Date.
  - f. Because the Maximum Aggregate Offering Price field is optional for the sub-items, this field can be left blank.
  - g. Repeat steps a. to f. depending on how many sub-items you want to carry forward.
6. To include the “Unallocated (Universal) Shelf” carry forward line,

- a. Select the form type of the earlier registration statement from which the “Unallocated (Universal) Shelf” securities are to be carried forward. The form types that you can select are F-3, F-4, N-2, S-3, and S-4. The POS AM submission type displays form types S-3, S-4, F-3, and F-4.
- b. Enter the file number of the earlier registration statement from which the “Unallocated (Universal) Shelf” securities are to be carried forward.  
Note: FEPT will display a warning message if the file number(s) provided for the Unallocated (Universal) Shelf sub-items do not match the file number provided for the “Unallocated (Universal) Shelf” line.
- c. Enter the Initial effective date of the earlier registration statement from which the “Unallocated (Universal) Shelf” securities are being carried forward.
- d. Enter the filing fee previously paid in connection with unsold securities to be carried forward.
- e. Enter the “Maximum Aggregate Offering Price” of the securities to be carried forward.
- f. Enter a fee note (optional) to disclose specific details relating to the fee calculation as necessary to clarify the information presented for the carry forward line in Table 1.
7. Click the [Save] button. The “Unallocated (Universal) Shelf” offering line with the sub-items are displayed in “Table 1: Newly Registered and Carry Forward Securities.”

Filers who are submitting a structured EX-FILING FEES exhibit in Inline XBRL format may use FEPT to add transaction valuation data in “Table 1: Transaction Valuation” for an Exchange Act filing.

During the voluntary compliance period, filers may continue to provide Offerings & Fees data and attach the EX-FILING FEES exhibit in official HTML or ASCII (rather than Inline XBRL) format to the fee bearing submission form types where fee header information is required (an unofficial PDF of this exhibit is optional).

The Offerings & Fees page includes the fee-relevant fields for your submission. Calculations for the estimated filing fees are automatically generated and displayed. For information on entering

Offering and Fees information, see Section 7.3.9.1, “Entering Offerings & Fees Information” in the EDGAR Filer Manual, Volume II.

## **1.7 Adding Narrative Disclosure**

With respect to shelf takedowns, filers may include a narrative disclosure specifying the Maximum Aggregate Amount or Maximum Aggregate Offering Price for post-effective amendments and prospectuses. FEPT will enable filers to include the narrative disclosure and include the Maximum Aggregate Amount or Maximum Aggregate Offering Price for the following submission types:

- N-2 POSASR
- POSASR
- POS AM
- 424B\* (424B1, 424B2, 424B3, 424B4, 424B5, 424B7, 424B8)

Filers who intend to only provide the narrative disclosure must select “Yes” as a response to the question “Provide Only a Narrative Disclosure?” and must specify the Maximum Aggregate Amount or Maximum Aggregate Offering Price, or both along with an explanation.

When a filer has attached an Inline EX-FILING FEES to a final prospectus for the related offering, the system will validate that the filer has included either:

- a. A narrative disclosure alone  
or
- b. A narrative disclosure and Table 1, Table 2, and/or Table 3 fee data when submitting 424B1, 424B2, 424B3, 424B4, 424B5, 424B7 424B8 filings.

Similarly, when the filer has attached an Inline EX-FILING FEES to an N-2 POSASR, POSASR, or POSAM submission the system will validate that the filer has included either:

- a. A narrative disclosure alone  
or
- b. Table 1, Table 2, and/or Table 3 fee data with or without a narrative disclosure when submitting the filings.

The system will generate a warning message if filers do not include the narrative tag and/or the tables.

Filers who are submitting a structured EX-FILING FEES exhibit in Inline XBRL format may use FEPT to add offset data in “Table 2: Fee Offset Claims and Sources.”

  - ii. Select the form or filing type (as specified in Appendix A, Section 2.1) of the earlier registration statement from which the offset is claimed, from the “Form or Filing Type” drop down list.
  - iii. Enter the file number of the filing from which the offset is being claimed in the “File Number” field.
  - iv. Using the date picker in the “Initial Filing Date” field, select the initial filing date of the earlier registration statement from which the offset is being claimed. All dates must be between 01-01-1980 and 12-31-2050.
  - v. Enter the dollar amount of the previously paid filing fee to be offset against the fee due in the “Fee Offset Claimed” amount.

Filers who are submitting a structured EX-FILING FEES exhibit in Inline XBRL format can use FEPT to add combined prospectus data in “Table 3: Combined Prospectuses”.

1. Select the + icon to add a combined prospectus line under “Table 3: Combined Prospectuses.”
2. Select “Rule 429” from the “Rule” drop down list.
3. Select the type of securities previously registered that may be offered and sold using the combined prospectus from the “Security Type” drop down list.
4. Enter the title of the class of securities previously registered that may be offered and sold using the combined prospectus, in the “Security Class Title” drop down list.
5. Select the form type (as specified in Appendix A, Section 2.1) of the earlier effective registration statement that registered securities that may be offered and sold using the combined prospectus from the “Form Type” drop down list.
6. Enter the file number of the earlier effective registration statement on which securities were previously registered that may be offered and sold using the combined prospectus in the “File Number” field.

**1.11 Footnotes**

Footnotes or fee notes of up to 10,000 characters may be included in a filing fee exhibit. An exhibit prepared using the FEPT will include footnotes directly below each fee table from which the footnote is referenced. A line that includes a footnote reference will have a number to the left of the line that corresponds to the number assigned to the footnote. This allows for clearly showing the linkage between lines and footnotes.

**Expanded filing fee table impact on information to be provided in footnotes:**

Prior to the effectiveness of the filing fee amendments adopted in 2021 (33-10997 (10/13/21)), the amount of information provided in fee tables was much more limited. Below are examples of how providing information in fee tables may reduce the need to provide information in footnotes:

- Offering lines in Table 1 include information regarding securities carried forward from a prior registration. Prior to the filing fee amendments, information regarding carry forward securities had to be provided in footnotes.
- Offset lines in Table 2 include information about offsets claimed and the offset sources. Prior to the filing fee amendments, information regarding offsets had to be provided in footnotes.

- Offering lines in Table 1 on amendment filings include information regarding securities that had been previously paid on prior filings for the registration. Prior to the filing fee amendments, this information was provided in footnotes.
- Offering lines in Table 1 include specific rule references. Including rule references in Table 1 reduces the need to reference rules in footnotes.
- Combined prospectus information is included in Table 3. None of this information had been provided in fee tables in the past. With the addition of Table 3, footnotes providing details on combined prospectuses may be reduced.

### 1.11.1 Using Other Document Sources to Construct Footnotes

Filers who elect to use a fee note from another document when constructing their fee exhibit in FEPT will need to follow the technical information provided in Chapter 5 of the EDGAR Filer Manual.

Copy/pasting from popular text editors such as Word (Doc, Docx) and Adobe Acrobat (PDF) is unlikely to work successfully as such editors have hidden formatting information that may cause issues when pasting directly from such documents into FEPT.

FEPT allows HTML markup specified in the EDGAR Filer Manual section 5.2.2, ASCII-encoded characters listed in Section 5.2.1.1, and all non-printable (control) characters listed below the table in Section 5.2.1.1 except the Form Feed (page break) character. However, in most cases, using UTF-8 or ANSI encoded characters listed in Section 5.2.1.1 should also work. When supported white-space characters are required for formatting purposes, filers should use the <pre> HTML element to enclose the necessary paragraph(s). For example:

Generally, removing formatting from text can be accomplished by first pasting the text into a text editor with no text formatting capabilities, such as Notepad (in Windows).

Text that has been conformed to meet FEPT specifications and pasted into Notepad, for example, can then be copied from Notepad and pasted into the FEPT interface without resulting in formatting issues.

### **1.14 Attaching of EX-FILING FEES Exhibit to a 424I Submission**

Filers attaching an EX-FILING FEES exhibit for a 424I submission may use FEPT to generate the exhibit. Below are steps to submit a 424I filing with an EX-FILING FEES exhibit using FEPT:

1. Access FEPT on an 424I submission by following steps documented in Section 1.2. Note that you must select the 424I submission type instead of Form S-1 submission, and provide the file number of the prior Form F-1, F-3, S-1 or S-3 filing in the ‘File Number’ field on the “Main” tab of the 424I submission form type



Redemptions and repurchases should be reported as positive values. Decimals are permitted but optional. This field is required. A value of zero is permitted.

When you save the EX-FILING FEES exhibit, FEPT will display the following warning message:



### 1.18 Attaching the Tagged Fee Exhibit (EX-FILING FEES) to EDGARLink Online forms

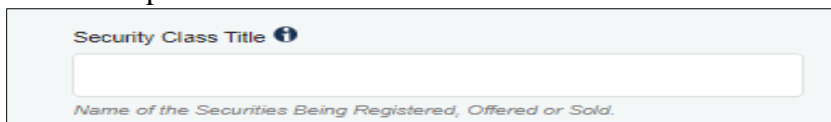
**Figure 20: Warning Report**
