Dale Wolf serves as a director of the Issuer as the representative of AssuredIM. In connection therewith, AssuredIM may be deemed to be a director by deputization of the Issuer.
- (2) This Form 144/A amends the Form 144 filed on November 17, 2020, in which the number of shares of the Issuer's Class A common stock reported to be sold was 417,619 shares. On November 17, 2020, BlueMountain Fursan Fund L.P. sold 417,619 shares of the Issuer's Class A common stock pursuant to Rule 144. As a result of an increase in the average weekly reported volume of trading of shares of the Issuer's Class A common stock during the four calendar weeks preceding the date of this Form 144/A relative to the four calendar weeks preceding the filing of the original Form 144, BlueMountain Fursan Fund L.P. is filing this Form 144/A to cover an additional 3,765 shares of the Issuer's Class A common stock currently expected to be sold pursuant to Rule 144 and to update the disclosures contained in Table II in connection therewith.
