

The shares granted on 2/9/2017, 2/15/18 and 2/14/2019 were granted as restricted stock and were fully vested on February 13, 2020. The other shares listed were issued under the issuer's Management Share Purchase Plan under which participants may elect to reduce a portion of their directors' fees and instead receive those amounts in the form of restricted shares of the issuer's common stock, and also receive a 25% matching grant of additional shares from the Company. The shares vested on the third anniversary of the dates given above. The amounts shown above are net of shares that were withheld by the issuer in satisfaction of withholding tax obligations incurred upon vesting.

² These shares were withheld by the issuer to satisfy withholding tax obligations incurred upon the vesting of restricted stock. They were not sold on the open market.
