ORDER APPROVING DISBURSEMENT OF FUNDS TO ELIGIBLE INVESTORS

The Court, having reviewed the Motion and Memorandum of Plaintiff Securities and Exchange Commission (the “Commission” or “SEC”) for an Order Approving Disbursement of Funds to Eligible Investors, and authorizing the Commission to disburse funds in accordance with the Distribution Plan to pay the Eligible Investors who suffered harm resulting from the Defendants’ conduct as alleged in the Complaint, without further order from the Court; and for good cause shown,

IT IS HEREBY ORDERED that:

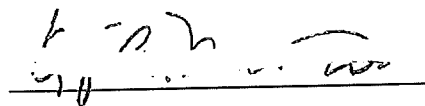
1. The Motion is **GRANTED**;
2. The Commission shall distribute the Distribution Fund, net of a reserve for taxes, tax reporting work, and administrative fees, and disburse \$53,627.09 to an escrow account established by the Third-Party at The Huntington National Bank, N.A. for distribution by the Third-Party to the Eligible Investors; and

3. The Third-Party shall distribute the funds to the Eligible Investors in accordance with the Distribution Plan as follows:

- a. The amount of \$1,079.89 to Eligible Investor #1
- b. The amount of \$1,079.89 to Eligible Investor #2
- c. The amount of \$539.94 to Eligible Investor #3
- d. The amount of \$1,144.68 to Eligible Investor #4
- e. The amount of \$539.94 to Eligible Investor #5
- f. The amount of \$1,619.83 to Eligible Investor #6
- g. The amount of \$2,159.77 to Eligible Investor #7
- h. The amount of \$1,079.89 to Eligible Investor #8
- i. The amount of \$2,159.77 to Eligible Investor #9
- j. The amount of \$2,159.77 to Eligible Investor #10
- k. The amount of \$6,479.31 to Eligible Investor #11
- l. The amount of \$2,159.77 to Eligible Investor #12
- m. The amount of \$1,079.89 to Eligible Investor #13
- n. The amount of \$3,239.66 to Eligible Investor #14
- o. The amount of \$539.94 to Eligible Investor #15
- p. The amount of \$2,159.77 to Eligible Investor #16
- q. The amount of \$3,455.63 to Eligible Investor #17
- r. The amount of \$20,517.82 to Eligible Investor #18
- s. The amount of \$431.95 to Eligible Investor #19
