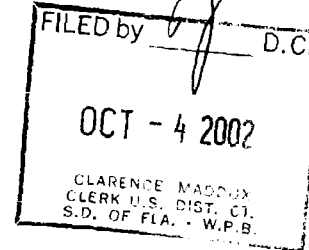

FINAL JUDGMENT ON DISGORGEMENT AND CIVIL PENALITES

THIS CAUSE comes before the court following this court's entry of final judgment against the defendants on April 4, 2002, and an order adopting the report and recommendation of the magistrate judge recommending disgorgement of monies and assessment of civil penalties against the defendants. The court hereby enters judgment as follows:

1. A disgorgement amount of \$3,828,000.00 (three million eight hundred twenty-eight thousand and .00 dollars), plus interest of \$1,987,346.00 (one million nine hundred eighty-seven three hundred forty-six and .00 dollars), for a total of \$5,815,346 (five million eight hundred fifteen thousand three hundred forty-six and .00 dollars) is assessed against the defendants, Keith Greenberg and Coyote Consulting and Financial Services, LLP, jointly and severally, that shall bear interest at the rate prescribed by 28 U.S.C. § 1961 from the date of entry of this order, for which let execution issue.
2. A civil penalty in the amount of \$100,000.00 (one hundred thousand and .00 dollars)


