**Order Granting Motion for
Final Default Judgment; Entry
of Final Judgment against
Derek J. Slattery and
Tradesmart Software RIC
Corporation**

ECF No. 38

21 Default was entered against Defendants Derek J. Slattery and TradeSmart
22 Software RIC Corporation on October 2, 2022, after they failed to defend against the
23 Securities and Exchange Commission's (SEC's) allegations in this securities-fraud
24 action. ECF No. 35. The SEC now moves for default judgment against these
25 defendants. ECF No. 38.

1 Because the SEC has established that default judgment is warranted under the
2 factors in *Eitel v. McCool*, 782 F.2d 1470, 1471 (9th Cir. 1986), for the reasons stated
3 in its memorandum of points and authorities, ECF No. 38, IT IS ORDERED that the
4 SEC's motion for entry of default judgment [ECF No. 38] is GRANTED.

5 So, with good cause appearing and no reason to delay, IT IS ORDERED,
6 ADJUDGED, AND DECREED that FINAL JUDGMENT is entered against
7 Derek J. Slattery and TradeSmart Software RIC Corporation ("Defendants")
8 as follows:

9 **I. Injunction against Exchange Act violations**

10 Defendants are permanently restrained and enjoined from violating, directly or
11 indirectly, Section 10(b) of the Securities Exchange Act of 1934 (the "Exchange
12 Act") [15 U.S.C. § 78j(b)] and Rule 10b-5 promulgated thereunder [17 C.F.R. §
13 240.10b-5], by using any means or instrumentality of interstate commerce, the mails,
14 or any facility of any national securities exchange in connection with the purchase or
15 sale of any security:

- 17 (a) to employ any device, scheme, or artifice to defraud;
 - 18 (b) to make any untrue statement of a material fact or to omit to state a
19 material fact necessary in order to make the statements made, in the light of the
20 circumstances under which they were made, not misleading; or
 - 21 (c) to engage in any act, practice, or course of business which operates or
22 would operate as a fraud or deceit upon any person.

23 As provided in Federal Rule of Civil Procedure 65(d)(2), the foregoing paragraph
24 also binds the following persons who receive actual notice of this Final Judgment
25 by personal service or otherwise: (a) Defendants' officers, agents, servants,
26 employees, and attorneys; and (b) other persons in active concert or participation
27 with any Defendant or with anyone described in (a).
28

1 **II. Injunction against Securities Act violations**

2 Defendants are permanently restrained and enjoined from violating Section
3 17(a) of the Securities Act of 1933 (the “Securities Act”) [15 U.S.C. § 77q(a)] in the
4 offer or sale of any security by the use of any means or instruments of transportation
5 or communication in interstate commerce or by use of the mails, directly or
6 indirectly:

7 (a) to employ any device, scheme, or artifice to defraud;

8 (b) to obtain money or property by means of any untrue statement of a
9 material fact or any omission of a material fact necessary in order to make the
10 statements made, in light of the circumstances under which they were made,
11 not misleading; or

12 (c) to engage in any transaction, practice, or course of business which
13 operates or would operate as a fraud or deceit upon the purchaser.
14

15 As provided in Federal Rule of Civil Procedure 65(d)(2), the foregoing paragraph
16 also binds the following persons who receive actual notice of this Final Judgment by
17 personal service or otherwise: (a) Defendants' officers, agents, servants, employees,
18 and attorneys; and (b) other persons in active concert or participation with any
19 Defendant or with anyone described in (a).

20 **III. Monetary Judgment**

21 Defendants are jointly and severally liable for: (1) disgorgement of
22 **\$1,051,866, representing net profits** gained as a result of the conduct alleged in the
23 complaint, **together with prejudgment interest thereon in the amount of**
24 **\$32,919.28**; and (2) **a civil penalty in the amount of \$1,057,366**, pursuant to
25 Section 20(d) of the Securities Act, 15 U.S.C. § 77t(d), and Section 21(d)(3) of the
26 Exchange Act, 15 U.S.C. § 78u(d)(3). Defendants must satisfy this obligation by
27 paying \$2,142,151.28 to the SEC within 30 days of entry of this Final Judgment.

1 Defendants may transmit payment electronically to the SEC, which will
2 provide detailed ACH transfer/Fedwire instructions upon request. Payment may also
3 be made directly from a bank account via Pay.gov through the SEC website at [http://](http://www.sec.gov/about/offices/ofm.htm)
4 www.sec.gov/about/offices/ofm.htm. Defendants may also pay by certified check,
5 bank cashier's check, or United States postal money order payable to the SEC, which
6 must be delivered or mailed to

12 and must be accompanied by a letter identifying the case title, civil action number,
13 name of this court, and the name of the defendant making the payment. The letter
14 also must explain that payment is made against this Final Judgment.

15 Defendants must simultaneously transmit photocopies of evidence of payment
16 and case identifying information to the SEC's counsel in this action. By making this
17 payment, Defendants relinquish all legal and equitable right, title, and interest in such
18 funds and no part of the funds will be returned to Defendants.

19 The SEC may enforce this judgment for disgorgement and prejudgment
20 interest by using all collection procedures authorized by law, including, but not
21 limited to, moving for civil contempt at any time after 30 days following entry of this
22 Final Judgment.

23 The SEC may enforce this judgment for penalties by the use of all collection
24 procedures authorized by law, including the Federal Debt Collection Procedures Act,
25 28 U.S.C. § 3001 *et seq.*, and moving for civil contempt for the violation of any court
26 orders issued in this action. Defendants must pay post judgment interest on any
27 amounts due after 30 days of the entry of this Final Judgment under 28 U.S.C. §
28 1961. The SEC will hold the funds, together with any interest and income earned

1 thereon (collectively, the “Fund”), pending further order of the court.

2 The SEC may propose a plan to distribute the Fund subject to the court’s
3 approval, which may direct that the Fund be distributed according to the Fair Fund
4 provisions of Section 308(a) of the Sarbanes-Oxley Act of 2002. The Fund may only
5 be disbursed in accordance with an order of the court.

6 Regardless of whether any such Fair Fund distribution is made, amounts
7 ordered to be paid as civil penalties in this judgment must be treated as penalties paid
8 to the government for all purposes, including all tax purposes. To preserve the
9 deterrent effect of the civil penalty, Defendants shall not, after offset or reduction of
10 any award of compensatory damages in any Related Investor Action based on
11 Defendants' payment of disgorgement in this action, argue that they are entitled to,
12 nor may they further benefit by, offset or reduction of such compensatory damages
13 award by the amount of any part of the payment of a civil penalty in this action
14 (“Penalty Offset”). If the court in any Related Investor Action grants such a Penalty
15 Offset, Defendants must, within 30 days after entry of a final order granting the
16 Penalty Offset, notify the SEC’s counsel in this action and pay the amount of the
17 Penalty Offset to the United States Treasury or to a Fair Fund, as the SEC directs.
18 Such a payment may not be deemed an additional civil penalty or deemed to change
19 the amount of the civil penalty imposed by this judgment. For purposes of this
20 paragraph, a “Related Investor Action” means a private-damages action brought
21 against Defendants by or on behalf of one or more investors based on substantially
22 the same facts as alleged in the complaint in this action.

IV.

This Court will retain jurisdiction of this matter for the purposes of enforcing the terms of this Final Judgment.
