DIVISION OF ENFORCEMENT'S RESPONSE TO GORDON BRENT PIERCE'S MOTION TO AMEND HIS MOTION TO VACATE THE COMMISSION'S ORDER

Respondent Gordon Brent Pierce ("Pierce") has filed a Motion to Amend his previously filed Motion to Vacate the Commission's Order ("Motion") in this proceeding ("Pierce I Proceeding") so that Pierce might ask the Commission to vacate also the Initial Decision in a different, subsequent administrative proceeding, In the Matter of Gordon Brent Pierce, Newport Capital Corp., and Jenirob Company Ltd., Admin. Proc. File No. 3-13927 ("Pierce II Proceeding"). The Pierce II Proceeding is currently before the United States Court of Appeals for the District of Columbia Circuit.

The Division of Enforcement ("Division") does not oppose Pierce's filing of an Amended Motion to Vacate the Commission's Order. However, the Division construes Pierce's present Motion to Amend as merely seeking leave to file an Amended Motion to Vacate. If Pierce's Motion to Amend is granted and Pierce subsequently files an Amended Motion to Vacate, the Division intends to file a substantive opposition to the Amended Motion to Vacate.

Alternatively, if the Commission deems Pierce's current Motion to Amend to be an Amended Motion to Vacate, the Division requests that the Commission issue an Order so stating and specifying that the Division would have five business days from issuance of such Order in which to file an opposition.
