## RENEWED ORDER TO SHOW CAUSE

On December 27, 2022, the Securities and Exchange Commission issued an Order Instituting Administrative Proceedings ("OIP") against Onwuka Afame (the "Afame Trust") pursuant to Section 17A(c)(3) of the Securities Exchange Act of 1934.<sup>1</sup> On February 6, 2023, the Division of Enforcement filed a declaration establishing that the OIP was served on the Afame Trust on January 9, 2023, pursuant to Commission Rule of Practice 141(a)(2)(iii).<sup>2</sup>

On March 1, 2023, the Commission issued an order directing the Afame Trust to show cause why this proceeding should not be determined against it due to its failure to timely answer the OIP's allegations.<sup>3</sup> But it appears that the order to show cause may not have been properly served on the Afame Trust. Under the circumstances, we find it appropriate to renew the order to show cause and extend the deadline by which the Afame Trust must file a response to that order. The prehearing conference and the hearing remain continued indefinitely.

We further note that, on April 5, 2023, the Division moved for an order of default and the imposition of remedial sanctions against the Afame Trust. Although it appears the Division properly served the motion on the Afame Trust, the Afame Trust did not file a response. Consequently, the Afame Trust must also address its failure to respond to the Division's motion when responding to this renewed show cause order.

Accordingly, the Afame Trust is ORDERED to SHOW CAUSE by September 21, 2023, why it should not be deemed to be in default and why this proceeding should not be determined against it due to its failure to file an answer and to otherwise defend this proceeding. The Afame Trust's submission shall address the reasons for its failure to timely file an answer, include a proposed answer to be accepted in the event the Commission does not enter a default against it,

and address the substance of the Division's request for sanctions. If the Afame Trust responds to this order to show cause, the Division may file a reply within 14 days after its service.

When a party defaults, the allegations in the OIP will be deemed to be true and the Commission may determine the proceeding against that party upon consideration of the record without holding a public hearing.<sup>4</sup> The OIP informed the Afame Trust that a failure to file an answer could result in deeming it in default and determining the proceeding against it.<sup>5</sup> The failure to timely oppose a dispositive motion is also a basis for a finding of default.<sup>6</sup> Like failing to file an answer, it may result in the determination of particular claims, or the proceeding as a whole, adversely to the non-moving party and may be deemed a forfeiture of arguments that could have been raised at that time.<sup>7</sup>

The parties' attention is directed to the e-filing requirements in the Rules of Practice.<sup>8</sup> We also remind the parties that any document filed with the Commission must be served upon all participants in the proceeding and be accompanied by a certificate of service.<sup>9</sup>
