We are in receipt of UASNM, Inc.'s Notice of Compliance and Request for Reconsideration with respect to the subpoena issued to it, along with the bills UASNM has submitted. Although we have started to review UASNM's bills, we are currently occupied with our preparation for the hearing commencing next week. Therefore, we will not have an opportunity to complete our review of UASNM's bills and prepare a response before the hearing begins. Based upon our partial review, we believe a substantial portion of the costs and fees claimed are unreasonable, objectionable, and not recoverable under any circumstances, and we would like an opportunity to fully address those issues by way of a written response once the hearing has concluded. A sampling of the issues we have identified so far includes, but is not limited to:

- The format of the production, i.e. producing the documents, which comprise 4.86GB of data, on hard-drives purportedly costing \$118.11, when it could have just as easily been produced on one or two DVDs at a cost of \$0.25 to \$0.75 each;
- UASNM's apparent production of duplicate documents previously produced which UASNM was repeatedly instructed not to produce; and
- Fees and costs wholly unrelated to the production of documents which are clearly not recoverable, e.g. fees for attorney time spent researching grounds to object to Respondent's subpoena and time spent drafting and revising UASNM's motion to quash.
